145. Crash Description/Narrative

Vehicle 1 was stopped in traffic behind Vehicle 2 at a red traffic signal on RT 88 eb at the intersection with

 Jordan Rd. Driver 1 took her foot off her break pedal and Vehicle 1 rolled forward into the rear of Vehicle 2.

Driver 1 stated she was stopped behind Vehicle 2 when she thought the traffic signal turned green. Driver 1

 stated she took her foot off her break pedal and started to roll forward when she realized the traffic signal was

 still red and the traffic ahead of her was still stopped. Driver 1 stated she had no time to apply her breaks

 again before rolling into the rear of Vehicle 2.

No injuries were reported by either party. Both vehicle's were driven from the scene and no motor vehicle

 summonses were issued.

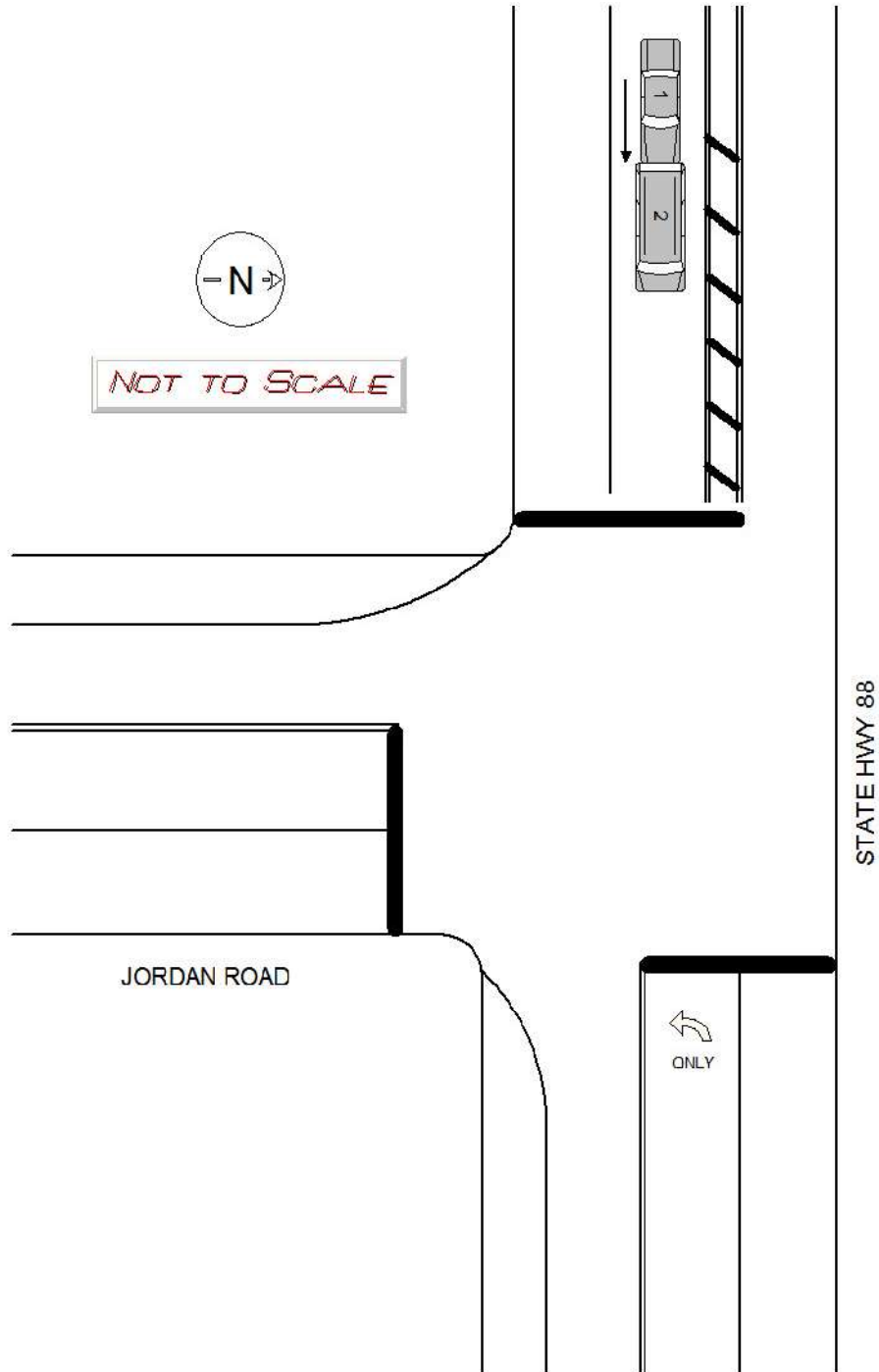
