145. Crash Description/Narrative

On arrival I observed two vehicles in the traffic. I observed on vehicle #1 front right moderate damage. Vehicle #2 had minor damage to the rear left. I was able to get the vehicles out of traffic and into a near by parking lot. At that time Driver #2 explained the following:

She was starting in traffic when she observed vehicle #1 coming up behind her quickly. At that time, vehicle #1 could not stop in time causing him to rear end her. After speaking to Driver #2, I spoke to Driver #1 who explained the following:

He was traveling westbound on Route 88 when he observed vehicle #2 in front of her. He attempted to stop but could not in time causing him to rear end her.

The passenger of vehicle #1 stated she hit her head when they crashed into vehicle #2. Brick EMS responded and treated her. She refused to have any further treatment.

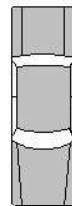
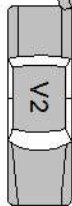
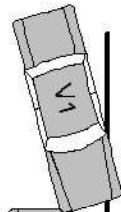
