145. Crash Description/Narrative

On scene investigation concluded: Vehicle #1 was traveling on Rt. 70 (Westbound) in the right lane of travel approaching the Olden St. intersection. Vehicle #2 was traveling across Rt. 70 from the Eastbound jug handle onto Olden St. Vehicle #2 was in the far right lane as it traveled across Rt. 70 onto Olden St. Vehicle #2 had almost completed crossing over Rt. 70 when it was struck in the right rear by Vehicle #1. Vehicle #1 had a clear sight path to observe Vehicle #2 crossing the intersection regardless of which vehicle had the right of way based on traffic signals. When Vehicle #1 struck Vehicle #2, Vehicle #2 was launched into a 180 degree spin before coming to rest on top of the curbed median. Vehicle #1 was determined at fault due to point of impact and ability to safely avoid the collision based on present driving conditions.

Driver of Vehicle #1 advised he was traveling on Rt. 70 when Vehicle #2 cut in front of him. Driver of Vehicle #1 stated he attempted to stop but struck Vehicle #2. Driver of Vehicle #1 advised he thought he had the green light.

Driver of Vehicle #2 advised she was stopped at the red traffic signal waiting to cross over Rt. 70 onto Olden St.

Driver of Vehicle #2 claimed she had the green traffic signal began to cross over Rt. 70 and had just about

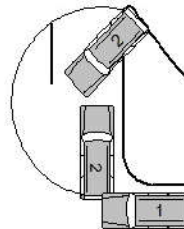
