145. Crash Description/Narrative

Vehicle #1 had stopped at the red traffic light on Olden St (one lane road) and waited to make a right turn onto Rt 88 heading east. Vehicle #1 had stopped to the right of Vehicle #2 which was already stopped waiting for the signal. Vehicle#2 made a right turn and sideswiped still stopped Vehicle #1.

The driver of Vehicle #1 stated that Vehicle #2 had left enough space in between it and the curb for his vehicle. He added that he wasn't sure where Vehicle #2 was going but he didn't believe that Vehicle #2 was using a blinker. He explained that he stopped halfway up Vehicle #2 and may have been in it's blind spot. When the traffic signal turned green, the driver of Vehicle #1 stated that Vehicle #2 made a right turn and sideswiped his vehicle before continuing on Rt 88 E/B. The driver of Vehicle #1 stated he had to catch up to Vehicle #2 and advise him of the crash and to pull over.

The driver of Vehicle #2 stated he was stopped at the aforementioned traffic signal when he attempted to make a right turn on red. He explained that he didn't see Vehicle #1 when he did so nor did he know that he had gotten into a crash until the driver of Vehicle #2 stopped him.

No injuries were reported on scene.

Based on the fact that the roadway was one lane, Vehicle #1 should not have pulled up on the right side of Vehicle #2. If he was unsure where Vehicle #2 going, he should have waited behind Vehicle #2 until it continued

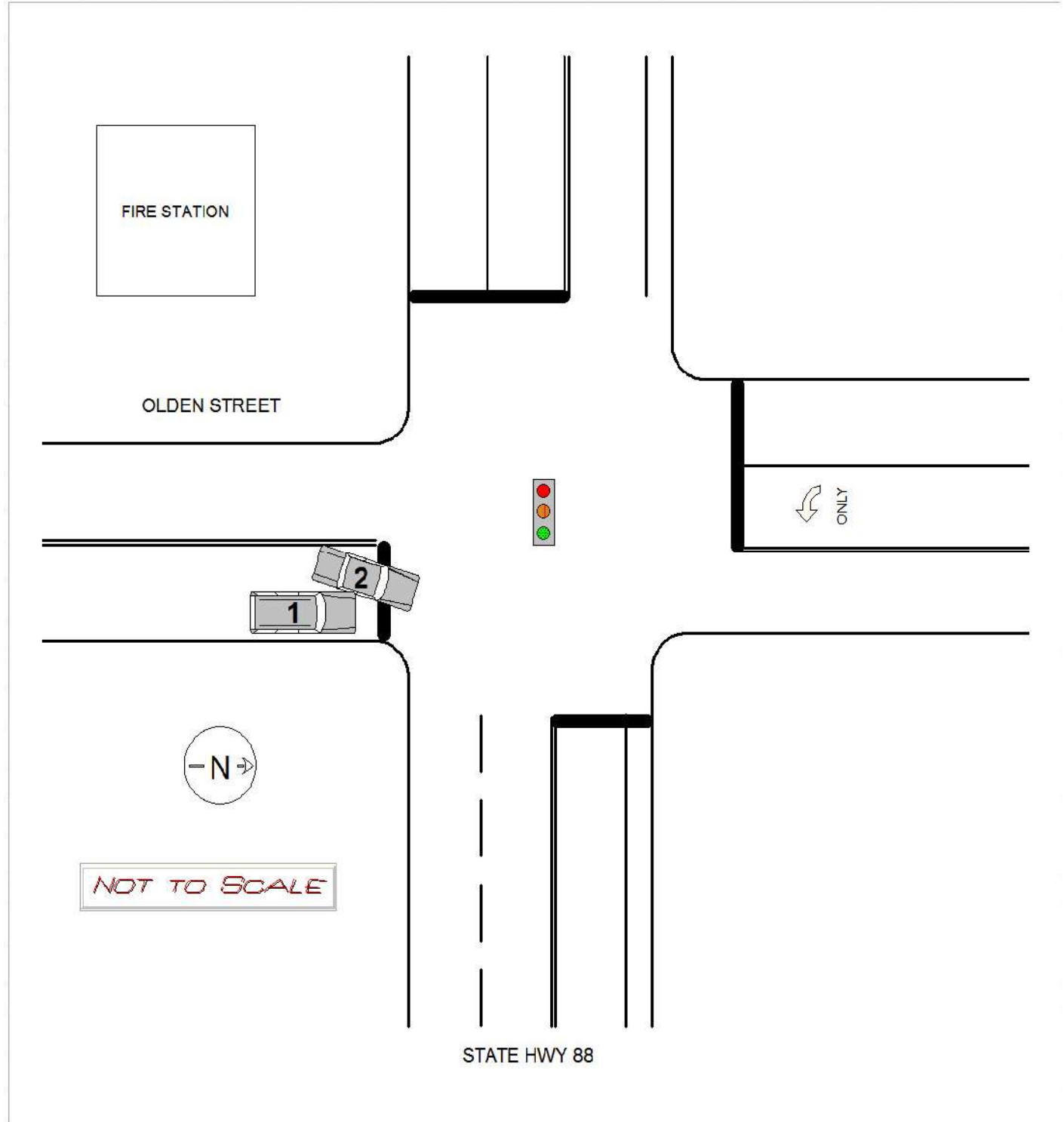
