On arrival I observed vehicle #2 had minor front driver side damage to his vehicle. Vehicle #1 had minor rear passenger side damage to his vehicle. I spoke to Driver #2 who explained the following:

He was approaching the traffic light at Route 70 when it turned green. He was not at a complete stop so he continued to go through the traffic light. Prior to going through the traffic light he observed vehicle #1 in the far right lane. With the momentum of his vehicle he was able to pass vehicle #1. He then explained vehicle #1 began to tail gate his vehicle. As he was traveling Northbound on Jack Martin Blvd. Vehicle #1 then passed over the double yellow line and struck his vehicle. Vehicle #1 continued to travel northbound and vehicle #2 followed him. After speaking to driver #1 I spoke to driver #2 who explained the following:

145 Crash Description

He was in the far right lane on Route 70 and Jack Martin Blvd when vehicle #2 passed him. He believed vehicle #2 cut him off and became irate. Driver #1 admitted he was tailgating vehicle #2 and passed over the double yellow line and passed vehicle #2. Driver #1 explained he did not know he struck their vehicle so he continued to go home.

Based on my observations and the admission from Driver #1, I find Driver #1 at fault for the crash.

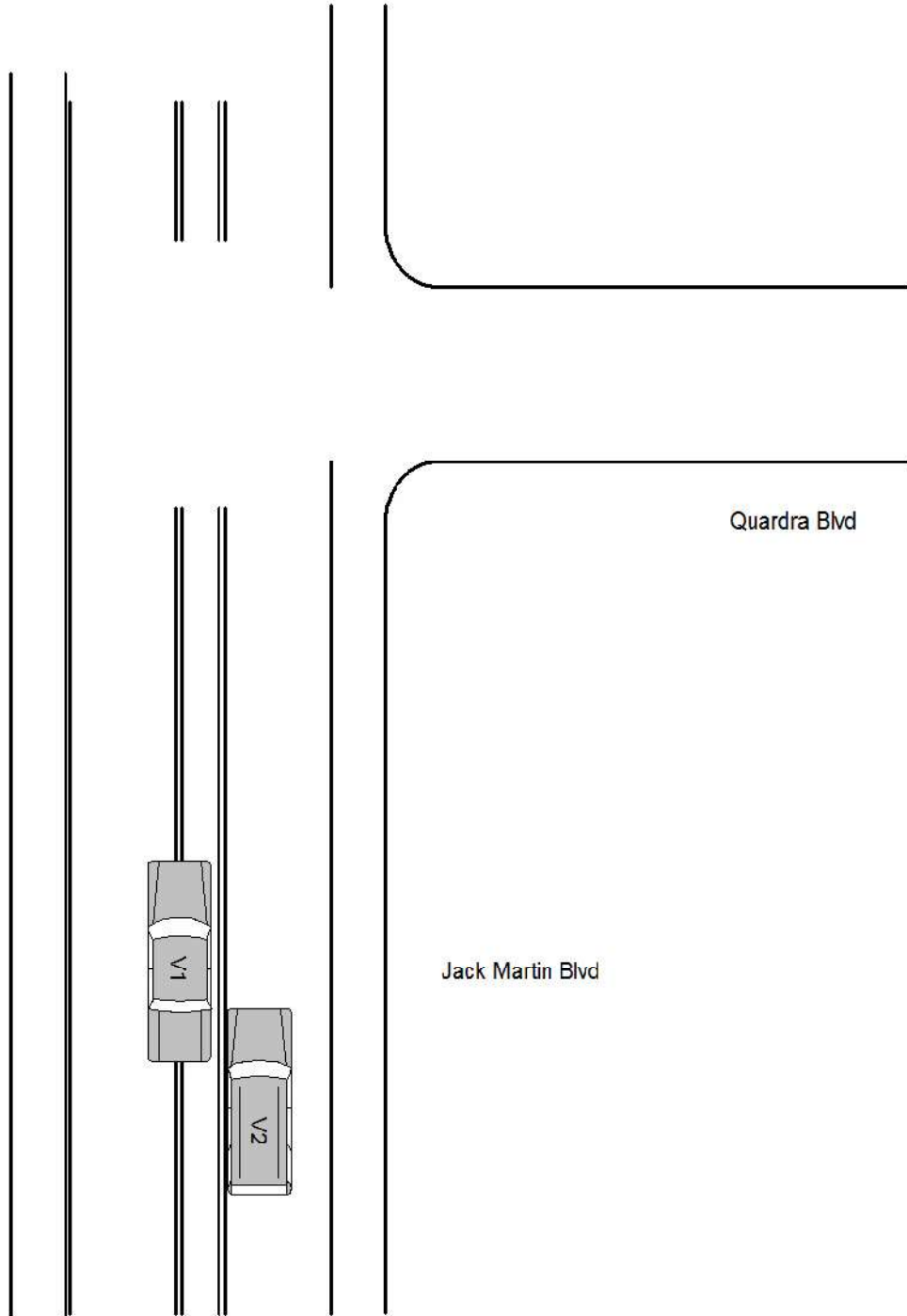
