145. Crash Description/Narrative

Vehicle 1 and vehicle 2 were traveling on Rt 88 East approaching Olden St. Vehicle 2 was ahead of vehicle 1 and was stopped due the red light at the intersection. Vehicle 1 was unable to stop in time and collided with the rear of vehicle 2, and then left the scene of the crash prior to police arrival.

Vehicle 1 was described a beige colored Hyundai Elantra , no registration available, with a female driver and left on Rt 88 towards Point Pleasant. Ptl. Zimmerer#272 checked the area for vehicle 1 with negative results.

The driver of vehicle 2 stated she was stopped at the light on Rt 88 East just before Olden St , when vehicle 1 collided with the rear of her vehicle.

There were no reported injuries at the scene, and minor damage was observed to the rear of vehicle 2.

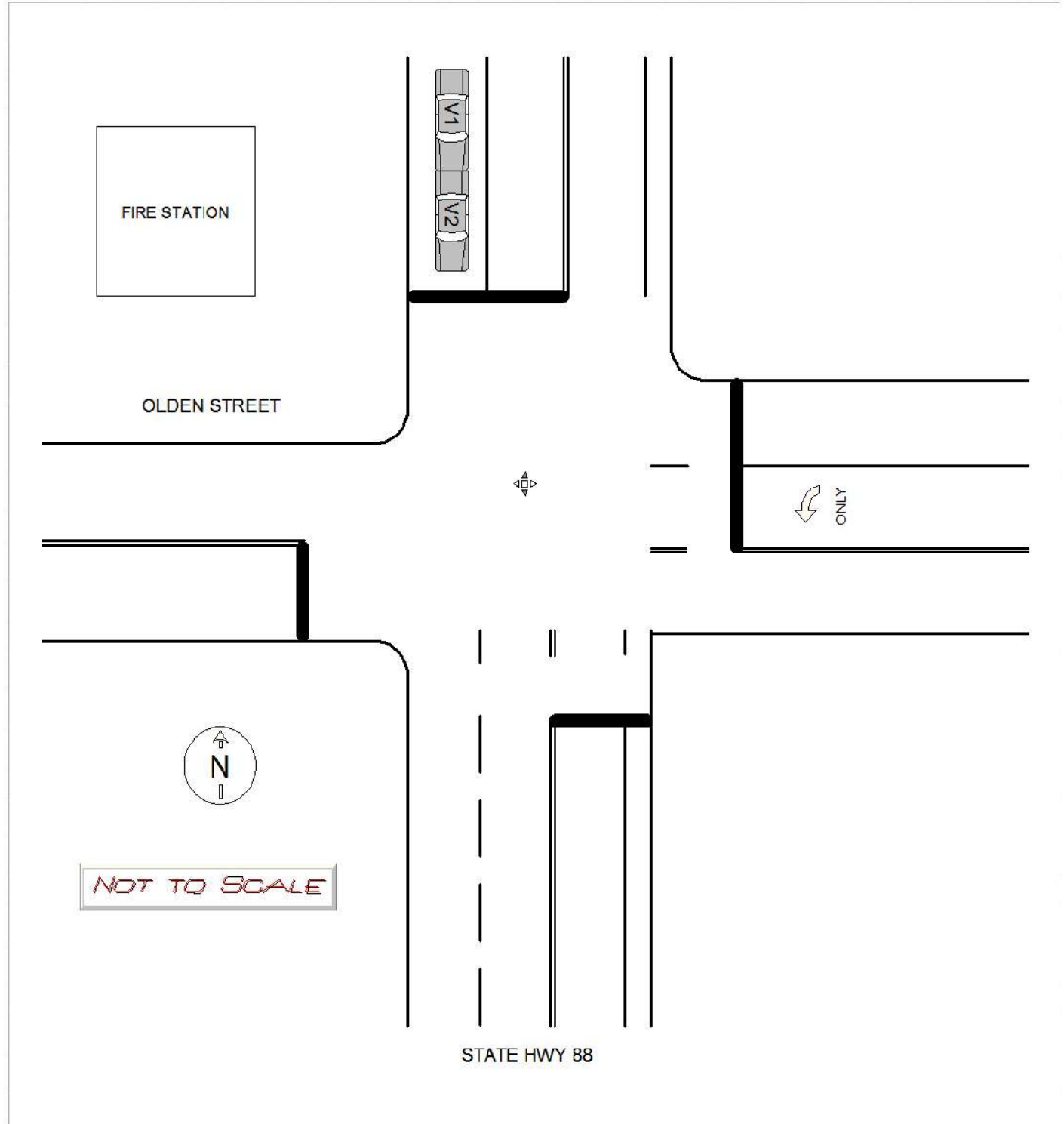
