145. Crash Description/Narrative

Vehicle#1 was traveling West on Route 88 near the area of Burrsville Rd. Vehicle#2 was traveling directly in front of Vehicle#1. Vehicle#1 proceeded to attempt to pass Vehicle#2 on the shoulder causing Vehicle#1 to strike Vehicle#2. Driver#1 stated that Driver#2 was driving slow and "break checking" him. Driver#1 stated that due to Driver#2's driving he attempted to pass him on the shoulder at which time the crash occurred. Driver#2 stated that Driver#1 was tailgating him. Driver#2 stated that as he approached Burrsville Rd. Driver#1 attempted to pass him on the shoulder and side swiped his vehicle. Driver#1 was determined to be at fault. Drivers and occupants refused first aid, vehicles were moved prior to arrival.

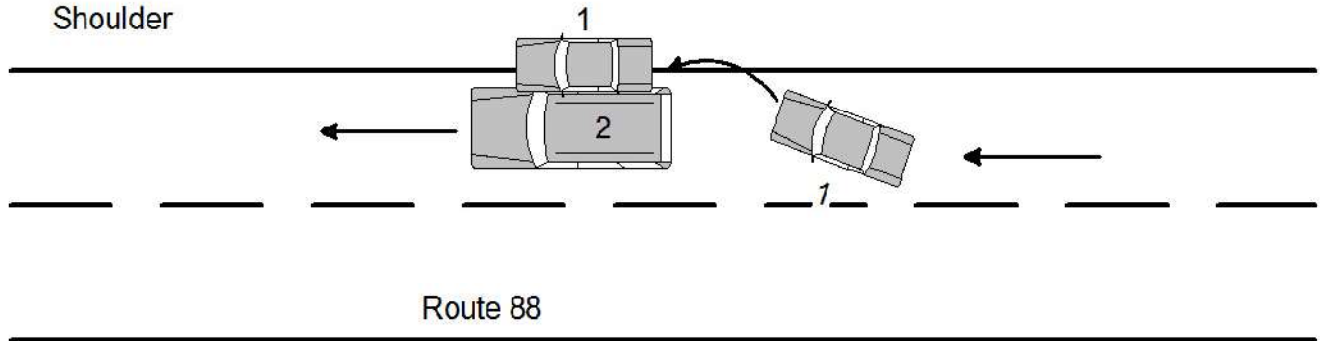
