145. Crash Description/Narrative

Vehicle 1 was making a right turn on red from Jack Martin Boulevard onto Burrsville Road. Vehicle 2 was traveling north on Burrsville Road in the intersection of Jack Martin Boulevard. Vehicle 1 failed to observe Vehicle 2 in the intersection and struck Vehicle 2, causing the crash.

Driver 1 stated the following: she was making a right turn from Jack Martin Boulevard onto Burrsville Road. She did not see Vehicle 2 in the intersection before making the turn, when she struck Vehicle 2. Driver 1 advised she did have the red traffic signal.

Driver 2 stated she was traveling north on Burrsville Road in the intersection of Jack Martin Boulevard. While in the intersection Vehicle 1 made a right turn from Jack Martin Boulevard and struck her vehicle. Driver 2 advised she had the green traffic signal.

Both Vehicles were moved prior to my arrival. There was no reported injuries on scene. Both vehicles were driven from the scene by their respective drivers. Driver 1 was issued summons E18-004459, 39:4-81, Failure to Observe Traffic Signal.

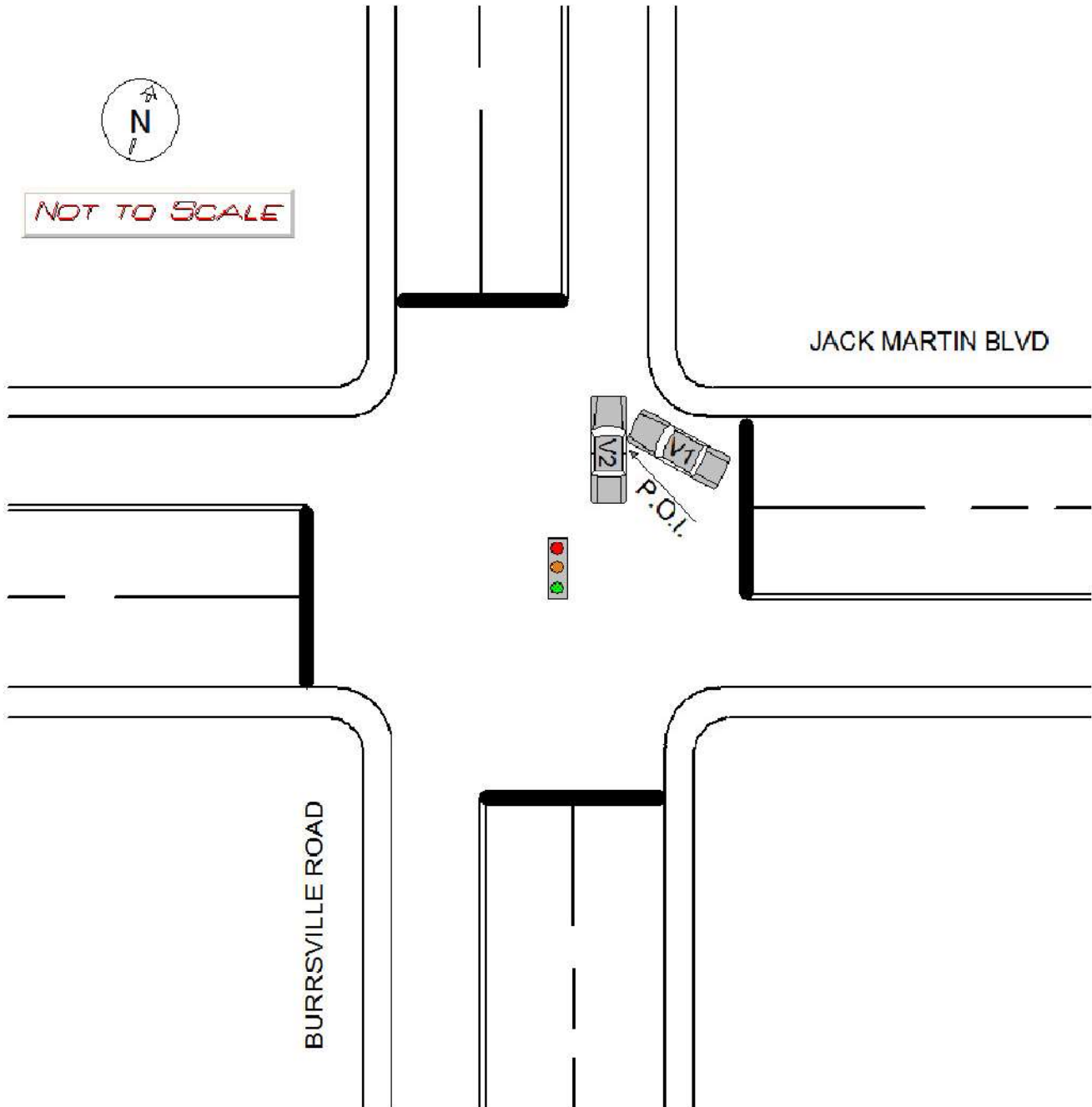
