145. Crash Description/Narrative

Vehicle 1 was parked, facing West in the lane of travel at 425 Jack Martin Blvd (Brick Hospital). Vehicle 2 was driving West in the lane of travel. The driver of vehicle 2 saw vehicle 1 parked on the side of the road.

Vehicle 2 then attempted to go around vehicle 2, when vehicle 1 turned back into the lane of travel, causing vehicle 1 to crash into vehicle 2.

The driver of vehicle 1 stated, "I was stopped, with my blinker on, attempting to make a left hand turn onto the road to access the parking garage. When on coming vehicles passed, I began my turn and a small vehicle attempted to pass on my left and crashed into my left front bumper."

The driver of vehicle 2 stated, "I was traveling through the hospital parking lot. I saw the other vehicle parked on the side of the road, past the entrance way to the parking garage, so I began to pass on the left side. Once I was next to the other vehicle, it turned left into my vehicle."

Vehicle 2 sustained damages to the front right fender and bumper. The damages to vehicle 2 were disabling, causing the driver of vehicle 2 to contact AAA.

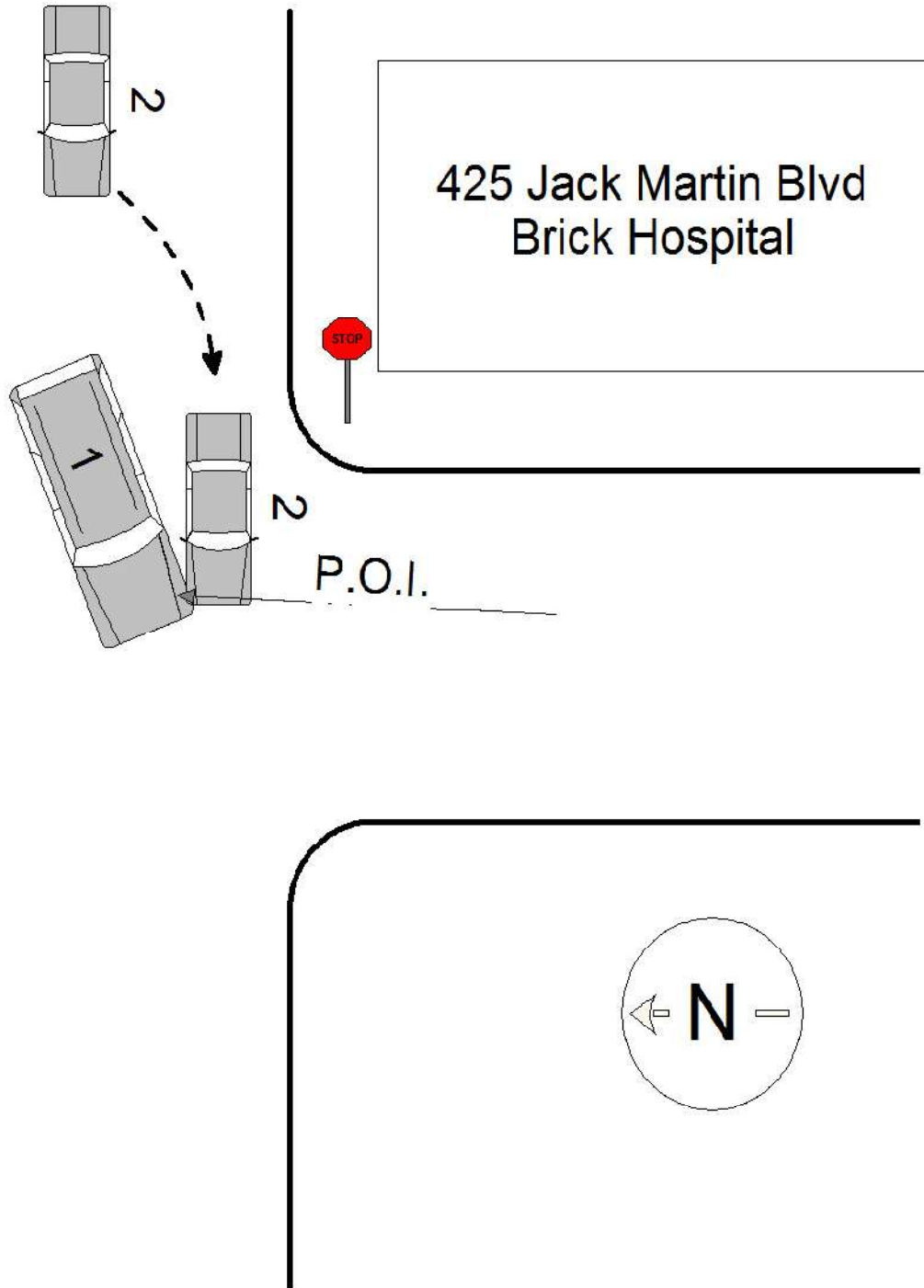
