145. Crash Description/Narrative

Vehicle 1 and 2 were located at Ocean Medical Center, 425 Jack Martin Blvd traveling westbound on a connecting road within the complex. Vehicle 2 yielded to pedestrian in the walkway. Vehicle 1 failed to observe Vehicle 2 stopped and collided with the rear of it.

The driver of vehicle 1 advised she was traveling westbound behind vehicle 2. Driver 1 further advised she did not realize vehicle 2 had stopped and as a result collided with the rear of it.

The driver of vehicle 2 advised she was traveling westbound when a pedestrian was attempting to cross the roadway. Driver 2 stopped for the pedestrian then was struck from the rear by vehicle 1.

The driver of vehicle 1 is found at fault for the collision.

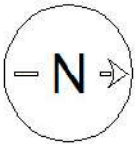

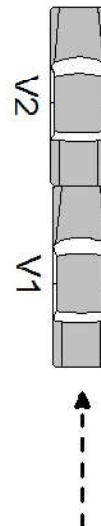
144 Crash Diagram (NOT TO SCALE)
