145. Crash Description/Narrative

Vehicle 1 and 2 were traveling West on RT 70. Vehicle 2 was slowing down behind another vehicle in the right lane, when vehicle 1 struck the rear of vehicle 2.

The driver of vehicle 1 stated, "I changed lanes and didn't realize the other vehicle was slowing down. When I attempted to stop, I was too close and crashed into the other car."

The driver of vehicle 2 stated, "I was slowing down because the car in front of me was making a turn into the Brick Diner. When I slowed down, I felt a car crash into the back of my vehicle."

Neither party sustained any injuries.

Upon completion of my investigation, vehicle 1 was to be found at fault.

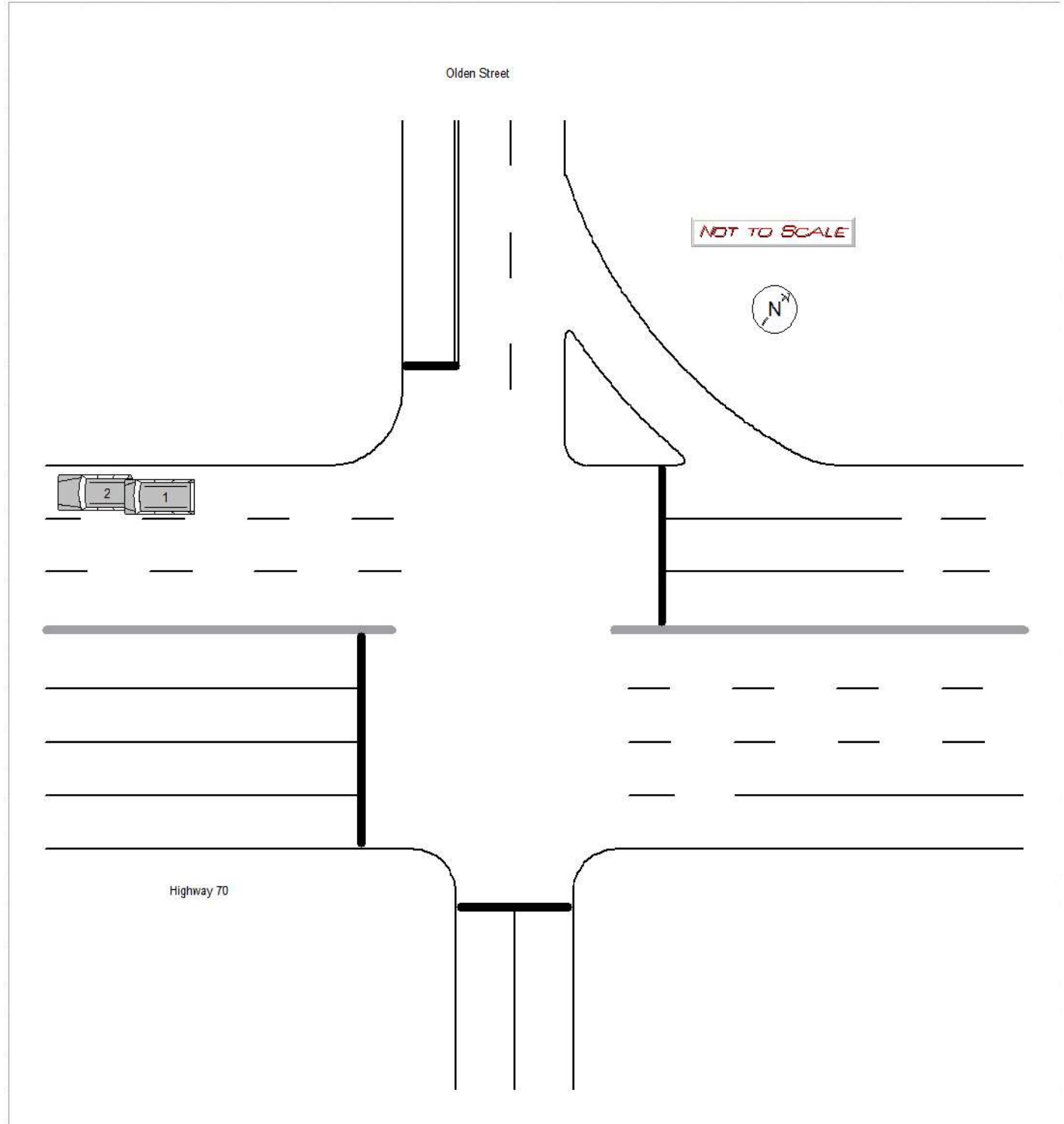
