145. Crash Description/Narrative

Accident investigation revealed that vehicle 2 was traveling southbound on RT 88 crossing over RT 70. Vehicle 1 was traveling eastbound on RT 70 crossing over RT 88. Both vehicles were in the roadway upon my arrival and a witness was stopped in the shoulder of the roadway.

Driver of vehicle 1 stated that she was traveling straight down RT 70 and did not remember seeing the traffic light. Vehicle 1 continued through the intersection and struck vehicle 2 in the middle of the intersection.

Driver of vehicle 2 stated that she had the green light and was crossing over RT 70 onto Princeton Ave when all of a sudden vehicle 1 went through the red light and hit her causing vehicle 1 to spin around.

I then spoke with a witness on scene who stated that he was waiting at the traffic light with vehicle 2 to cross over RT 70 towards Princeton Ave. As their light turned green, they proceeded through the intersection and vehicle 1 went through the red light on RT 70 traveling eastbound and struck vehicle 2 causing it to spin around.

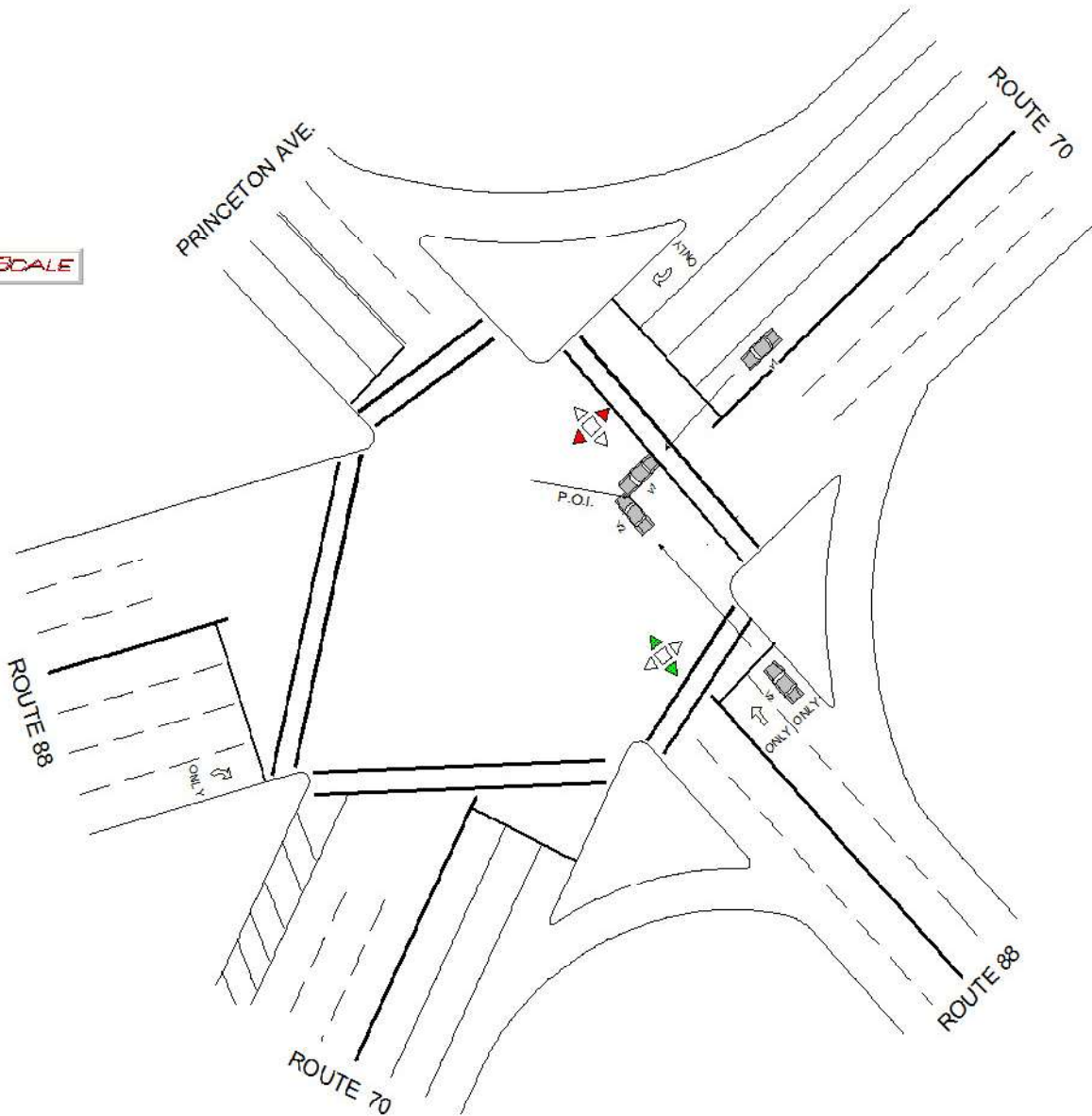
