145. Crash Description/Narrative

Upon arrival, vehicle #2 was on the westbound shoulder of Rt. 88 and vehicle #1 was in the parking lot of 1608 Rt. 88.

Driver #2 stated he was traveling westbound on Rt. 88 when vehicle #1 pulled out of the parking lot from 1608 Rt. 88 to make a left turn onto Rt. 88 eastbound. Driver #2 stated vehicle #1 pulled out right in front of him subsequently colliding into vehicle #1's left rear panel causing damage to the bumper and rear tire. Driver #2 stated he was unable to stop or swerve out of the way to avoid the collision. Vehicle #2 sustained significant damage to the left front panel/bumper.

Driver #1 stated he was attempting to make a left turn onto Rt. 88 east bound from the parking lot of 1608 Rt. 88. Driver #1 said he thought he had enough time to attempt the left turn and believed driver #2 sped up causing the collision. Vehicle #1 sustained damage to the left bumper and rear tire due to the collision with vehicle #2.

All parties involved refused medical attention.

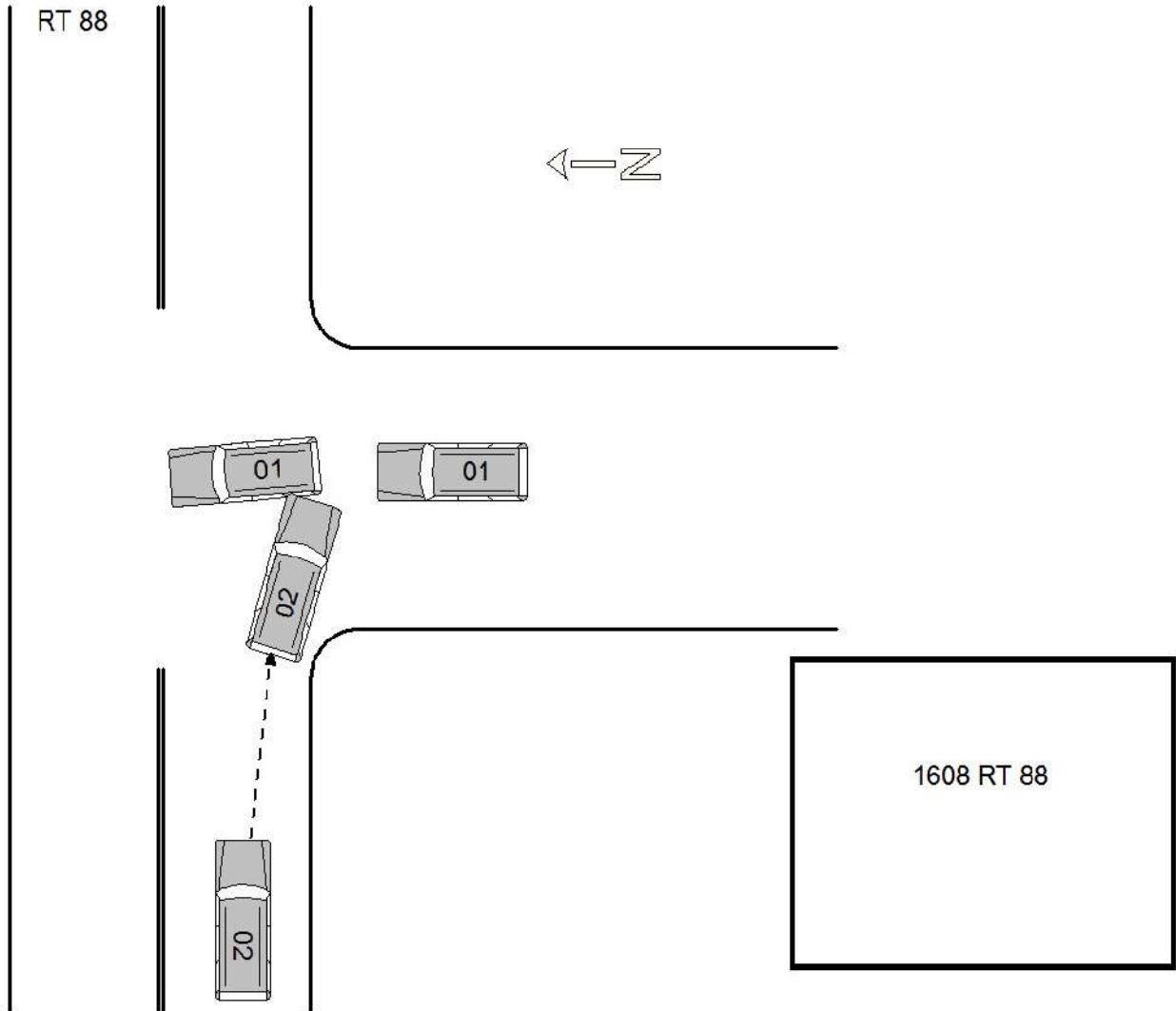
