145. Crash Description/Narrative

Vehicle #2 was traveling westbound on the ramp from Route 70 to Olden St. and slowed down at a yield sign.

Vehicle #1 was traveling westbound on the ramp from Route 70 and Olden St. and struck vehicle #2 in a rear end crash.

The Driver of Vehicle #2 stated she yielded at the Yield sign but then came to a complete stop because of traffic when her vehicle was struck in the rear.

The Driver of Vehicle #1 stated while slowing down behind vehicle #2 her foot slipped off the brake causing her vehicle to continue forward and into vehicle #2.

Vehicle #2 had minor damage to the rear bumper. Vehicle #1 had minor damage to the front bumper and license plate.

Based on my observations and statements by the parties involved I found the driver vehicle #1 at fault for the crash.
