145. Crash Description/Narrative

On 11/5/18 at 2215 hours I was dispatched to 1654 W. Princeton Ave in reference to a hit and run motor vehicle accident.

Upon arrival I observed vehicle 2 legally parked and unoccupied on Hoffman St. directly between W. Princeton Ave and Rt 88. Vehicle 2 had damage to its lower left bumper and debris from a black vehicle was on the ground surrounding it. The debris appeared to be from a front bumper and a head light. Vehicle 1 was no longer on scene.

The debris left on scene from vehicle 1 were consistent with the damage found on a vehicle that was stopped by Ptl. Riccio #289. The vehicle was previously reported as leaving a bar while the driver was highly intoxicated. The vehicle was located and stopped near the area of the hit and run (Reference - C# 66449-18).

Driver 1 was ultimately placed under arrest by Ptl. Riccio #289 for DUI and claimed to have no recollection of the motor vehicle accident.

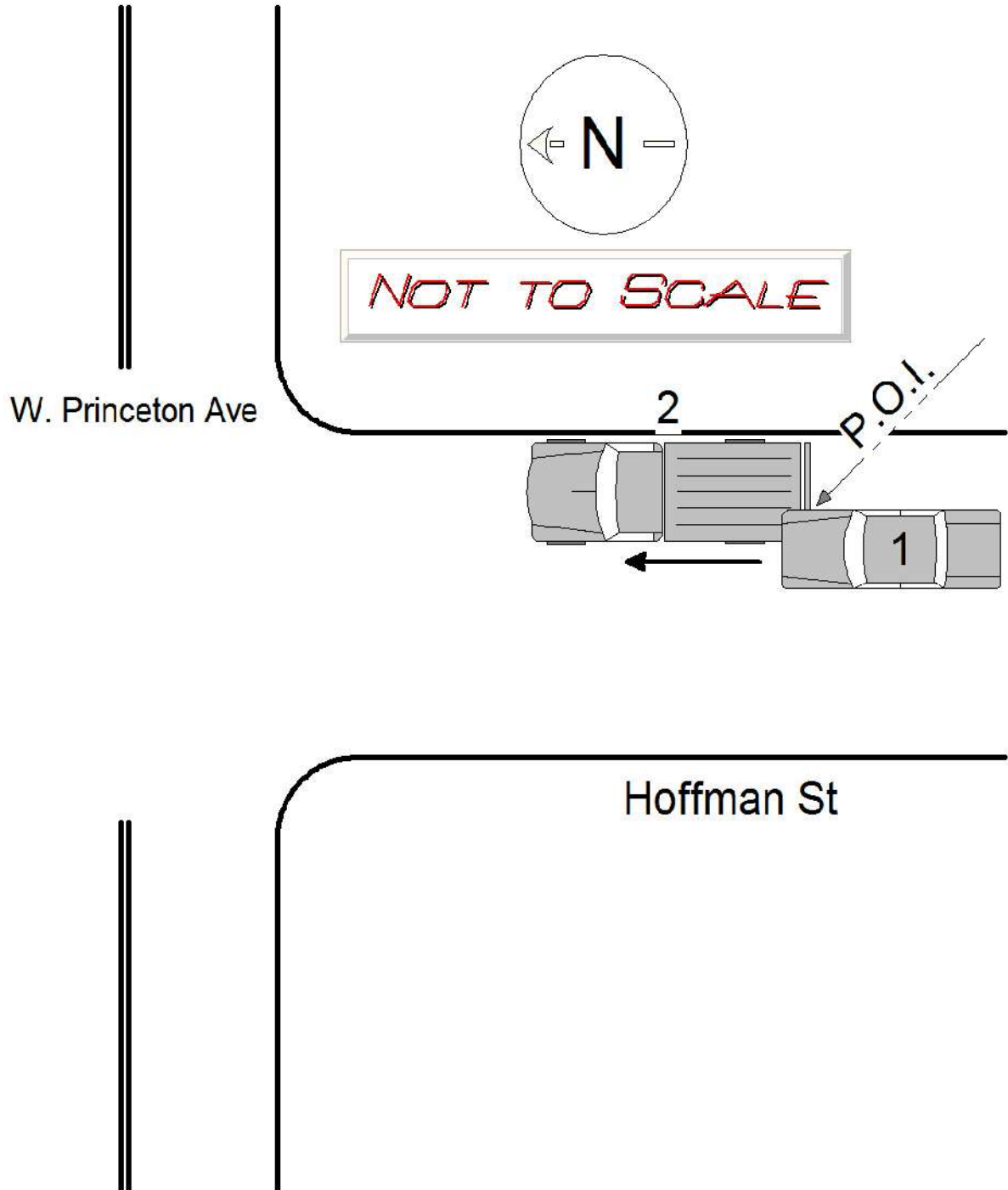
