145. Crash Description/Narrative

Vehicle 2 was traveling north on Post Rd. in the left lane, and was stopped for traffic due to a red traffic signal. Vehicle 1 was traveling north on Post Rd. in the left lane and was stopped directly behind Vehicle 2.

While vehicle 2 was stopped Vehicle 1 proceeded forward and rear ended Vehicle 2.

Driver of Vehicle 1 stated he was distracted by a passenger in the vehicle, at which time his foot let off the brake, rear ending Vehicle 2.

Investigation reveals that Driver of vehicle 1 was at fault for the collision due to being distracted.

No injuries reported at the scene. Vehicles were moved prior to police arrival.

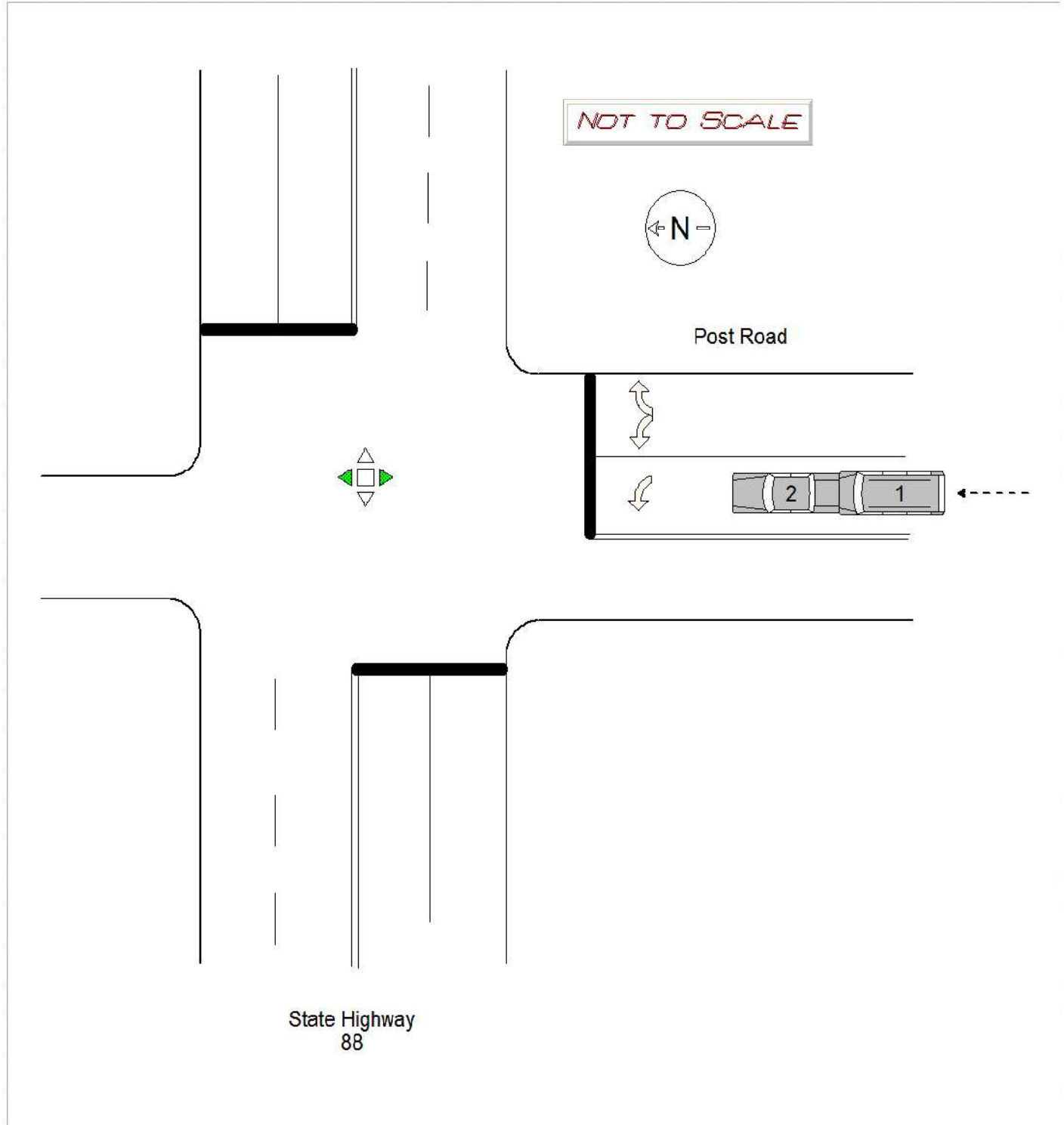
