145. Crash Description/Narrative

Vehicle 01 backed into Vehicle 02 on Post Rd. in the north bound right lane.

Driver of Vehicle 01 stated while picking up a garbage can with the robotic arm of his garbage truck he realized he had passed and missed a garbage can at #9 Post Rd. As he attempted to backup approximately 10' he had struck unseen Vehicle 02 that was directly behind him.

Driver of Vehicle 02 stated she was driving north on Post Rd. in the right lane and had stopped for Vehicle 01 picking up a garbage can from #9 Post Rd. Vehicle 01 then suddenly backed into the front of Vehicle 02. Vehicle 02 stated she was blowing her horn with no reaction from Vehicle 01.

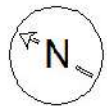
