145. Crash Description/Narrative

On location I observed vehicle #1 disabled in the eastbound lane of route 88 with front end damage. Vehicle #2 was also in the eastbound lane with disabling front end damage with front airbag deployment.

Driver #2 explained she was traveling eastbound on Route 88 when she observed vehicle #1 making a left turn into the Home Depot. Driver #2 was unable to stop and crashed into vehicle #1.

Driver #1 explained she was attempting to make a left turn into the Home Depot when she thought she could make the turn before vehicle #2 got close. Driver #1 then accelerated to make the left which caused her to crash into vehicle #2. Driver #1 also stated she caused the crash for attempting to make the left turn.

Driver #1 had complaint of pain in her chest. Brick EMS responded to the scene and treated Driver #1 but refused any other medical treatment.

Driver #1 was issued a summons for careless driving: 1506-T-154904

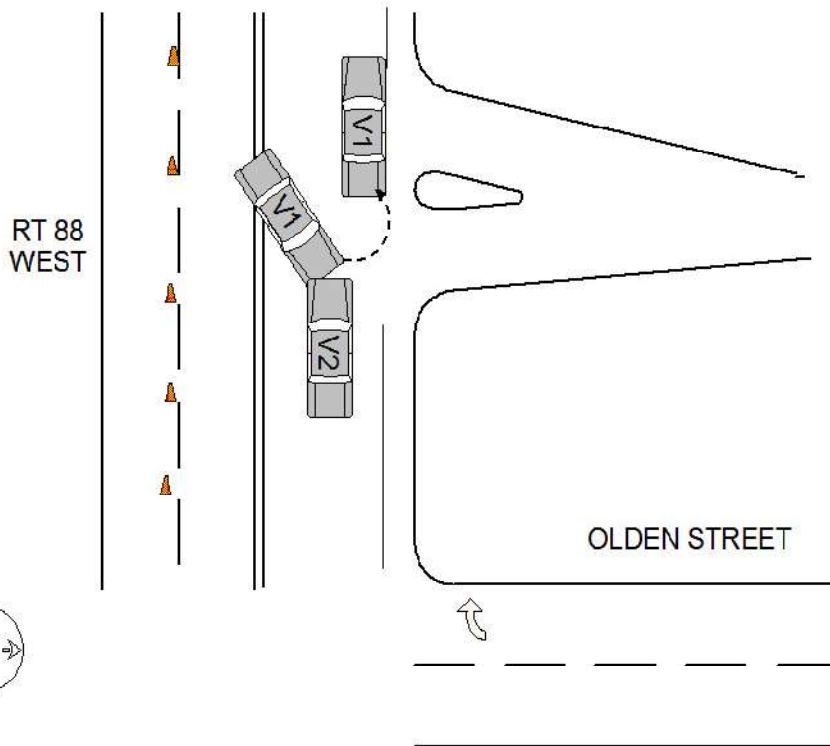
