145. Crash Description/Narrative

On 9/17/2021 at 1830 hours, I responded to the area of Burrsville and Jack Martin for a 2 vehicle crash.

The driver of vehicle 1 stated, she was trying to make a left from Jack Martin onto Burrsville when vehicle 2 was coming straight across Jack Martin and struck her vehicle.

The driver of vehicle 2 stated, she was on Jack Martin Blvd. and was going straight through the intersection of Burrsville Road, when vehicle 1 turned in front of her. The driver of vehicle 2 stated due to the rain, she was unable to stop and struck vehicle 1.

Vehicle 1 had damage to the passenger side of the vehicle and was towed from the scene.

Vehicle 2 had damage to the passenger side headlight, front bumper, and passenger side fender.

Due to the statements made by both drivers, I determined that the driver of vehicle 1 was at fault for the crash due to her not yielding to the right of way of traffic. My department issued body worn camera was activated during this incident.
