145. Crash Description/Narrative

A motor vehicle collision occurred in the parking lot of the Complete Care of Laurelton (475 Jack Martin Boulevard). Vehicle 02 was traveling straight ahead north bound in the parking lot headed for the main exit onto Jack Martin Boulevard. Vehicle 01 was traveling east bound horizontal to vehicle 02 in the same parking lot headed for the main exit. Vehicle 01 entered the intersecting travel lanes to make a left turn within the parking lot at the same time as vehicle 02. This caused the front passenger side corner of vehicle 01 to strike the driver side middle of vehicle 02.

While on scene, there were no reported injuries and all parties declined medical attention.

Driver 01 stated he was traveling in the parking lot of the Complete Care of Laurelton headed for the exit. Driver 01 said he stopped prior to the intersecting travel lanes within the parking lot to make a left turn towards the exit. Driver 01 advised he began to make a left turn when he then observed vehicle 02 to his right traveling at a high rate of speed towards him. Driver 01 explained he was unable to stop in time to prevent the motor vehicle collision.

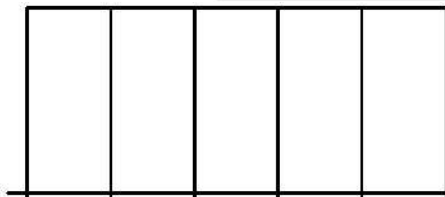

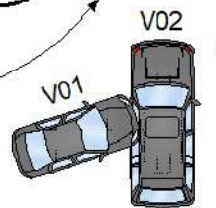
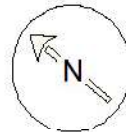

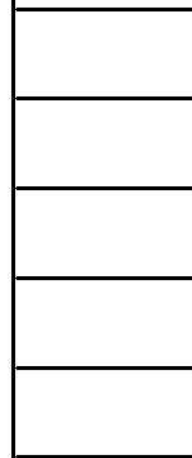
