145. Crash Description/Narrative

Vehicle 1 was making a left turn onto Route 88 west bound from the left most lane of Post Road. Vehicle 2 was traveling west down route 88 approaching the intersection of Route 88 and Post Road. Both vehicles entered the intersection and the right side of Vehicle 1 struck the left side of Vehicle 2. Vehicle 1 then continued forward and struck the traffic signal pole adjacent to pole number BT227BK. Vehicle 2 then continued forward and struck pole number BT227BK.

The driver of Vehicle 1 stated that she had a green light while making a left turn onto Route 88 from Post Road. While entering the intersection, she felt her vehicle strike something and applied the brakes. Her vehicle then continued forward and struck the traffic signal pole. The driver of Vehicle 1 suffered a minor injury to her neck from her seatbelt and thought that she was experiencing contractions from child delivery. She was transported to Ocean Medical Center to be further evaluated.

The driver of Vehicle 2 stated that she had a green light while continuing straight down Route 88 at the intersection of Post Road. She stated that she observed Vehicle 1 enter the intersection while she was in the intersection and attempted to swerve to her right to avoid a collision. She stated that Vehicle 1 struck her

vehicle and she then continued forward and struck the pole.

Two witnesses observed the crash take place and completed a Witness Statement Form. Both witnesses were a few cars behind Vehicle 1 on Post Road. Witness 1 stated that she was attempting to make a right turn from Post Road onto Route 88 and observed the crash. She stated that she observed the light from Post Road onto Route 88 turn green and that Vehicle 2 traveled through a red light. Witness 2 stated that he was attempting to make a left turn onto Route 88 from Post Road four cars behind Vehicle 1. He stated that he observed the light turn green and saw Vehicle 1 begin entering the intersection. He stated that Vehicle 2 traveled through a red light while going down Route 88 and crashed into Vehicle 1.

After speaking with both drivers, both witnesses, and conducting my investigation, I determined the driver of Vehicle 2 to be at fault for the crash. The driver of Vehicle 2 was issued a summons for failing to stop at the traffic signal.

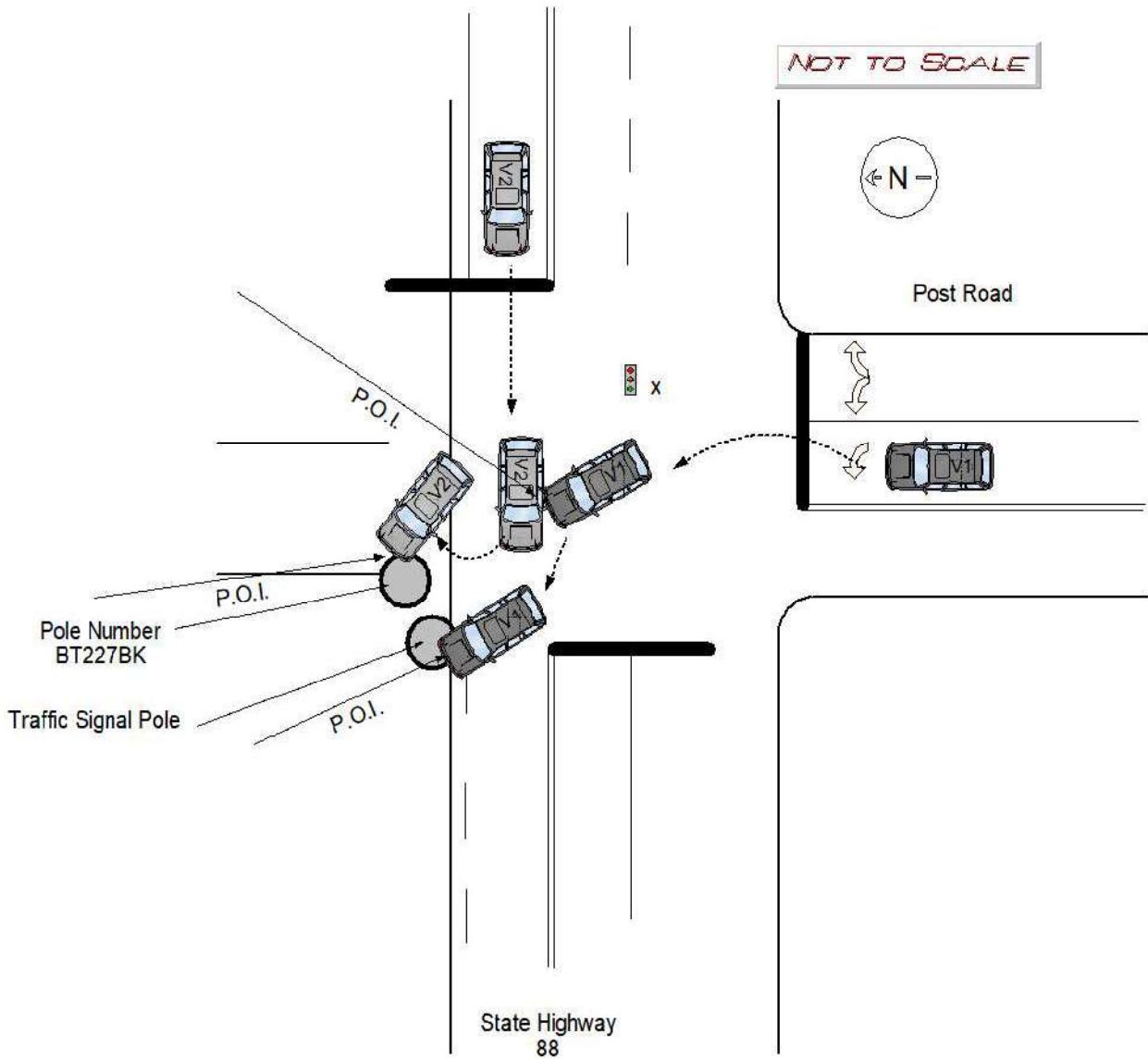
