145. Crash Description/Narrative

Vehicle 1 was stopped at the stop light on Post Road in the left hand turn only lane. Vehicle 2 was in the right hand turn lane making a left hand turn. Both vehicles made the left hand turn and as they turned onto Route 88, Vehicle 1 struck Vehicle 2.

In speaking with the driver of Vehicle 1, he stated he was stopped at the light in the left hand turn lane with Vehicle 2 directly to his right. As the light turned green, both vehicles started to drive. Driver 1 stated he accidentally drifted into Vehicle 2's lane and struck the rear driver side bumper. Driver 1 stated that it was his fault for the accident.

In speaking with the driver of Vehicle 2, he confirmed what the driver of Vehicle 1 stated.

Vehicle 1 had little to no damage to the vehicle while Vehicle 2 had moderate but functional damage to the rear driver side bumper which was torn off. No injuries were reported for this accident.

Based on the statements made by both parties and the facts of the investigation, Vehicle 1 is at fault for the

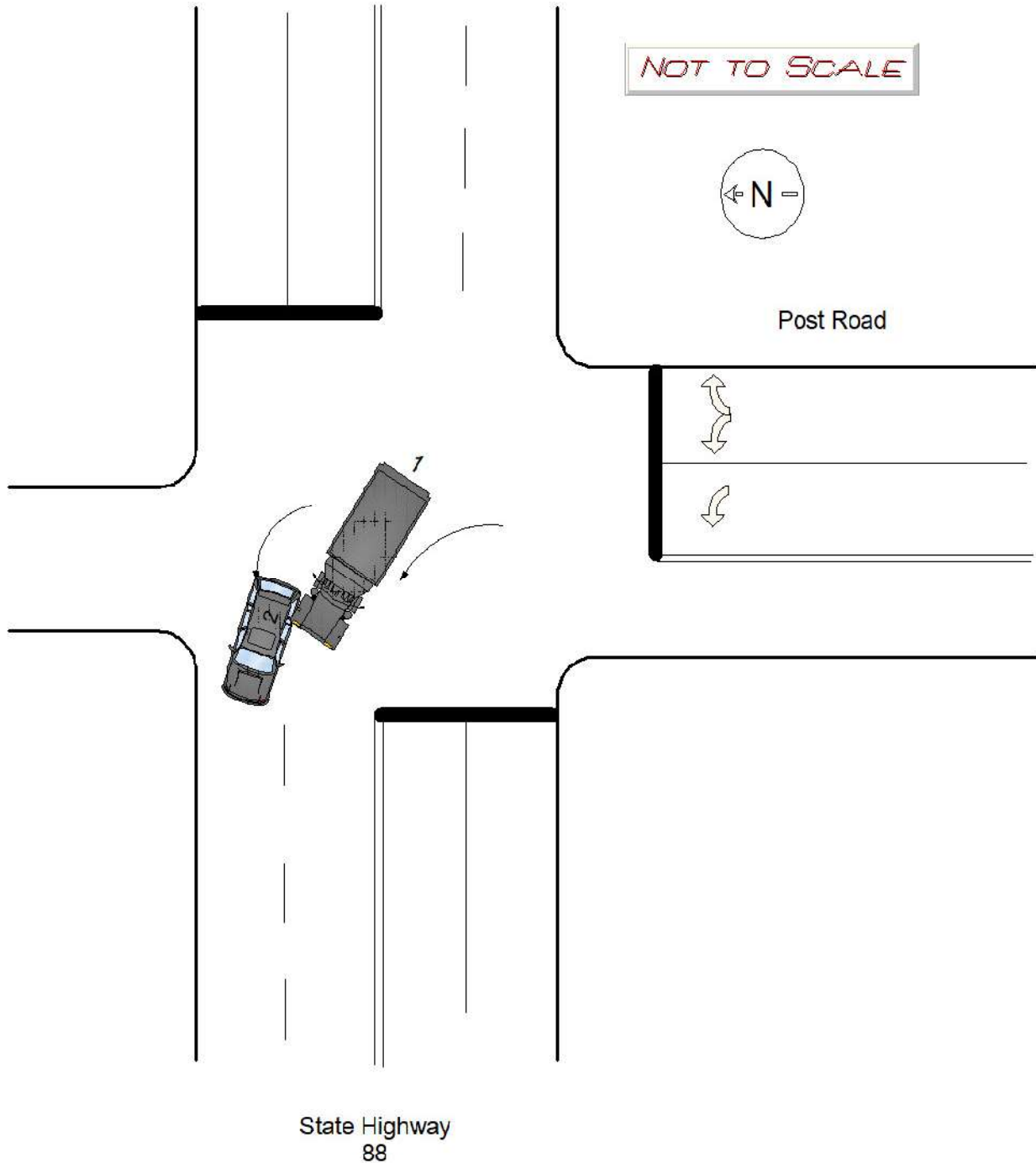
