145. Crash Description/Narrative

My investigation revealed the following: Vehicle 2 was traveling eastbound on RT-88 attempting to make a left over a into the Walmart parking lot. Vehicle 1 was traveling eastbound on RT-88 approaching vehicle 2. Vehicle 1 did not notice vehicle 2 was stopped and struck the rear of vehicle 2.

Driver 1 stated he was hauling a hot dog stand in the rear of his pickup truck. Driver 1 advised he looked into the rearview mirror to ensure the hot dog stand was still secure, and when he looked back down, he noticed brake lights. Driver 1 stated that when he noticed the brake lights, it was too late, and he could not stop in time.

Driver 2 advised he was stopped in the roadway waiting for the westbound travel lane to be clear. Driver 2 stated he was attempting to make a left turn into the Walmart parking lot.

Both drivers did not report injuries at this time. Both drivers were provided with a copy of the case number. My department issued body worn camera was active during the investigation.

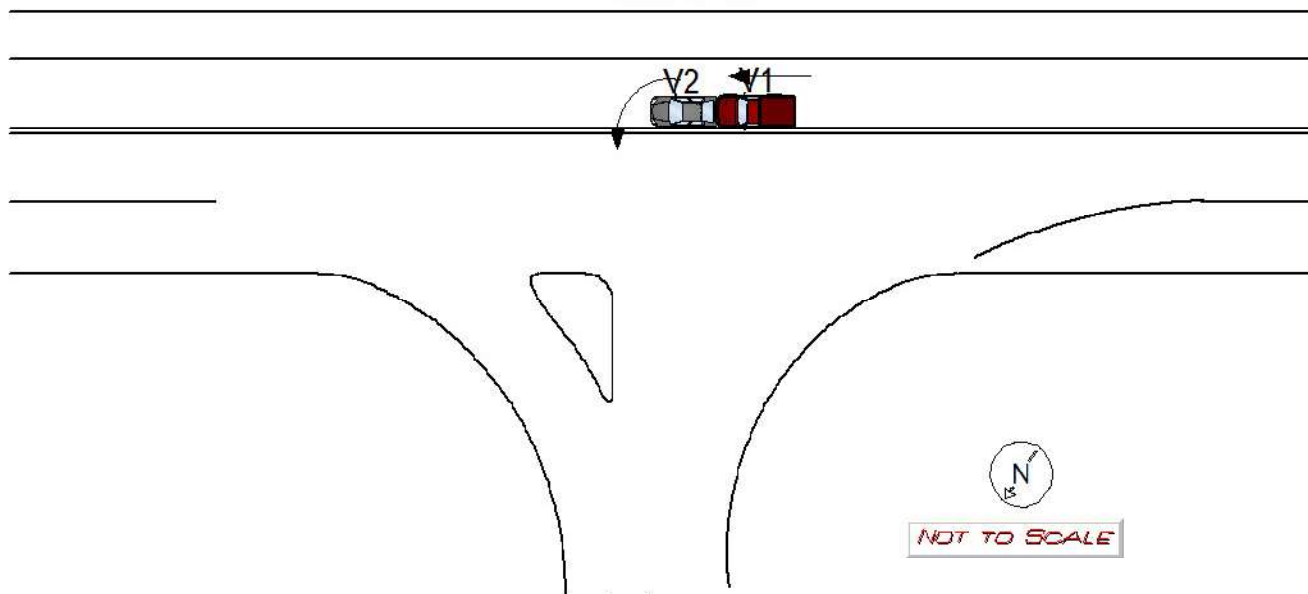
