145. Crash Description/Narrative

Vehicle #1 was traveling south on Jack Martin Blvd approaching the intersection of Rt. 70. Vehicle #2 was traveling south on Jack Martin Blvd behind Vehicle #1. Vehicle #2 passed Vehicle #1 in the middle lane and was struck in the left side by Vehicle #1.

Driver #1 stated that as she was approaching the intersection of Rt. 70 she went into the right turn lane to turn onto Rt. 70 westbound. Driver #1 stated that as she was in the right lane Vehicle #2 attempted to pass her on the right side and struck her vehicle. After striking her Vehicle #2 then went into the middle lane.

Driver #2 stated that she was in the middle lane of Jack Martin Blvd and wanted to turn left on Rt. 70. Driver #2 advised that Vehicle #1 was in the left turn lane and then turned into her in an attempt to get into the right turn lane.

After my investigation I am unable to determine who is at fault for the incident.

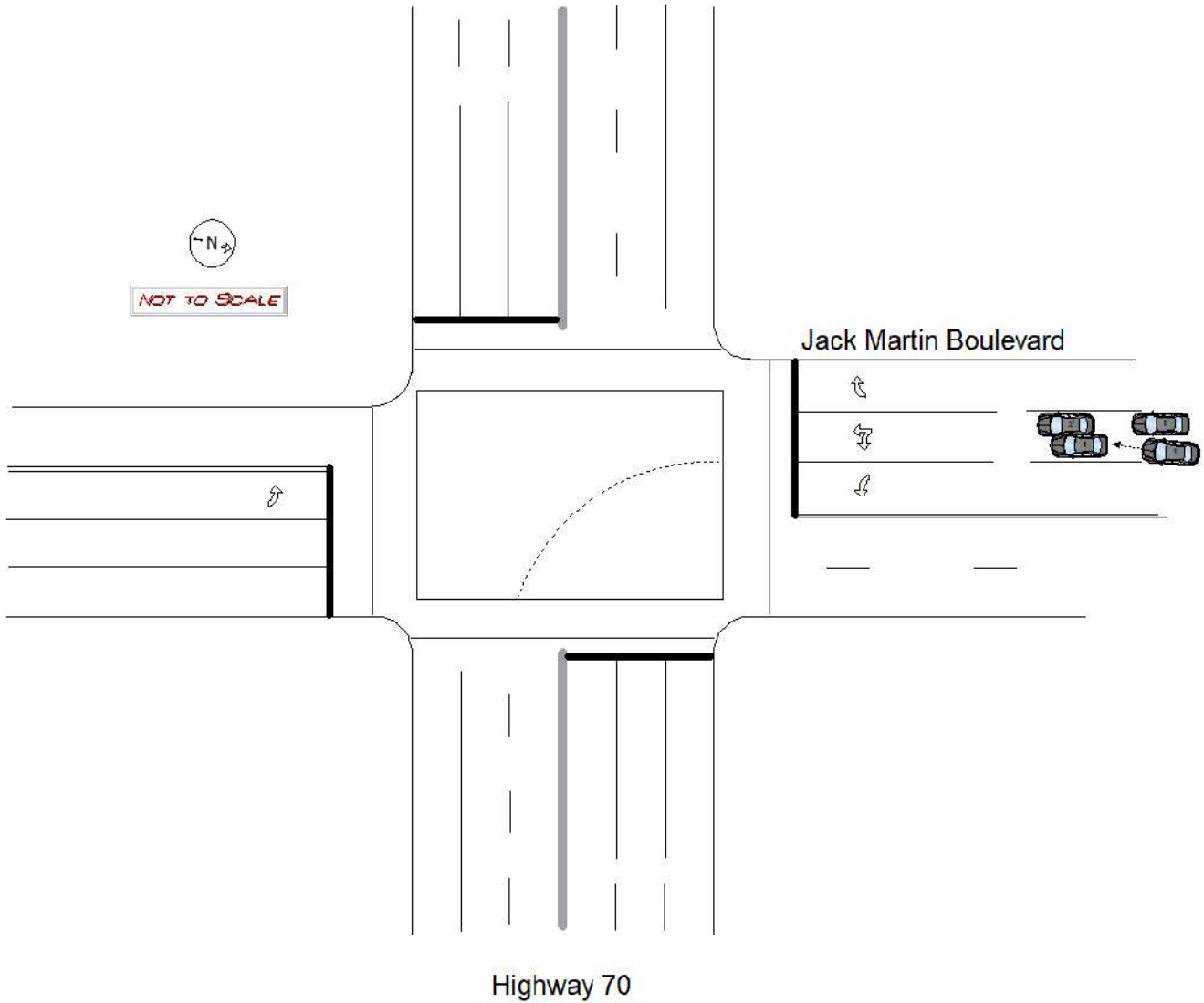
