145. Crash Description/Narrative

Vehicle #2 was traveling from Kessler Rehabilitation Center (1715 Rt. 88) across both lanes of Rt. 88 to Home Depot (1722 Rt. 88). Vehicle #1 was traveling West on Rt. 88 and struck Vehicle #2 as he was crossing Rt. 88 West. Vehicle #2 was struck and pushed into Rt. 88 East. Vehicle #3 was traveling East on Rt. 88 and Vehicle #2 struck the front left side of Vehicle #3. I observed significant front end damage to vehicle #2, front left damage and multiple airbag deployment to Vehicle #1 and front left damage to vehicle #3. All three vehicles were disabled and towed from the scene. Driver #1 had complaint of pain and transported to OMC for further treatment.

Driver #1 stated she was traveling West on Rt. 88 and Vehicle #2 drove out in front of her and she could not stop in time and struck the right side of his vehicle.

Driver #2 stated he was leaving Kessler Rehabilitation Center trying to cross Rt. 88 into the entrance of Home Depot. Driver #2 stated he did not see Vehicle #1 coming and believed he could make it across both lanes.

Driver #3 stated he was traveling East on Rt. 88 and observed Vehicle #2 attempt to cross over Rt. 88 and Vehicle #1 strike the side of Vehicle #2 causing it to crash into his vehicle.

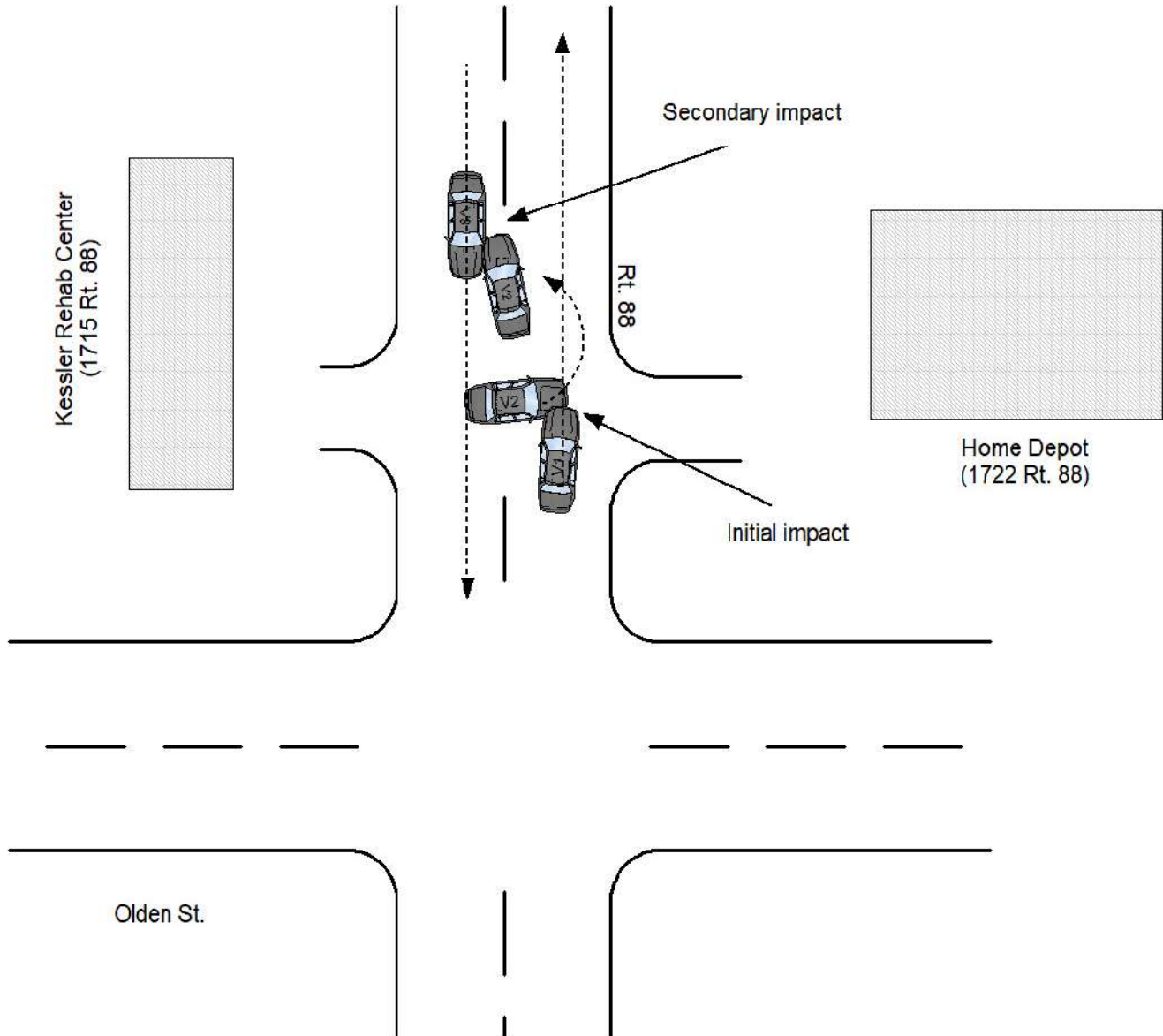
