145. Crash Description/Narrative

Vehicle #1 was backing out of a parking stall and struck Vehicle #2 traveling west in the parking lot of 1872 Route 88 (Walmart). The rear bumper of Vehicle #1 struck the passenger side doors of Vehicle #2.

Vehicle #1 operator stated while he was backing out of the parking stall, he did not see Vehicle #2 in his blind spot.

Vehicle #2 operator stated he was traveling through the parking lot when Vehicle #1 struck the passenger side of his vehicle.

No injuries were reported and both vehicles were moved prior to my arrival. Vehicle #1 operator determined to be at fault for improper backing and driver inattention.

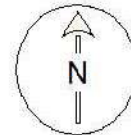

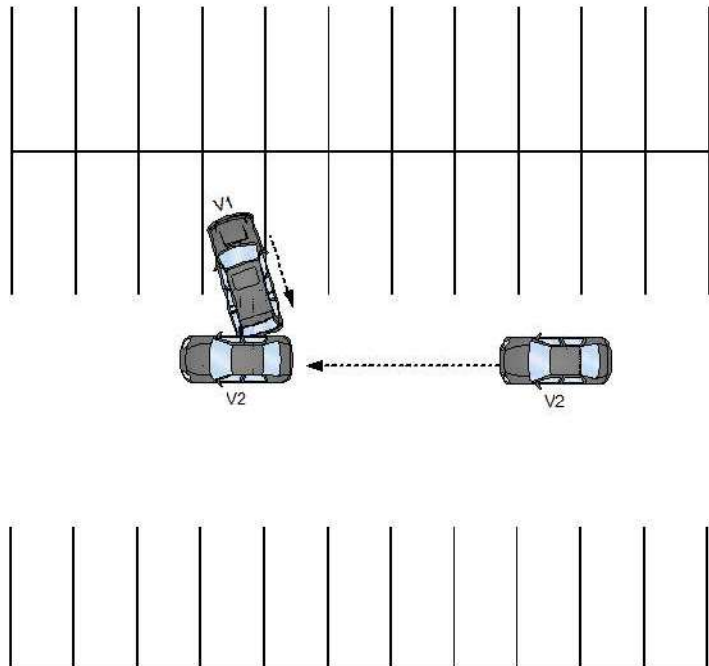
144 Crash Diagram (NOT TO SCALE)
