145. Crash Description/Narrative

A motor vehicle collision occurred on Route 70 west bound in the left most travel lane approximately 500 feet east of the intersection with Olden Street. Vehicle 02 was traveling on Route 70 westbound in the left most travel lane prior to the intersection with Olden Street. Vehicle 01 was traveling directly behind vehicle 02, failed to stop, and the front end of vehicle 01 struck the rear of vehicle 02.

While on scene, driver 01 reported no injuries and declined medical attention. Driver 02 reported he had complaints of pain in his back but declined medical attention.

Driver 01 stated she was traveling straight ahead on Route 70 west bound behind vehicle 02. Driver 01 said her phones had fallen onto the floor on the driver side causing her to get distracted. Driver 01 advised she attempted to apply her brakes as traffic began to slow down but her phone prevented her from doing so causing vehicle 01 to strike vehicle 02.

Driver 02 stated he was traveling on Route 70 west bound in the left travel lane approaching Olden Street. Driver 02 said he is unsure whether traffic was at a stop or if it was moving when he felt a jolt as vehicle 01 struck
