145. Crash Description/Narrative

Vehicles 1 and 2 were located on State Highway 88 in the area of the Home Depot (1722 Route 88, Brick). Both vehicles were in the eastbound lanes. Vehicle 1 was behind Vehicle 2.

Vehicle 2 was stopped in traffic in preparation to make a left turn into the Home Depot parking lot when it was struck from behind by Vehicle 1.

Driver of Vehicle 1 stated that he saw Vehicle 2 stopped in the roadway ahead of him, but when he went to apply his brakes, he skidded on the wet roadway and was unable to stop. He then crashed into the rear of Vehicle 2. Skid marks left on the roadway were measured at exactly fifty (50) feet.

Driver of Vehicle 2 stated they were stopped in traffic when Vehicle 1 struck them from behind.

Vehicle 1 sustained extensive front-end damage which rendered it disabled. Vehicle 1 was towed from the scene by Legacy Towing (Route 88, Brick). Vehicle 2 sustained moderate damage to the rear end and hitch, but it was able to be driven from the scene. No injuries were reported.

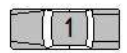
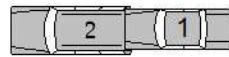
