145. Crash Description/Narrative

Investigation at the scene revealed: The driver of V2 (vehicle 2) was traveling westbound in the middle lane on Route 70 and was approximately 10 feet east of Forge Pond Road. The driver of V1 (vehicle 1) was traveling westbound in the right lane on Route 70 and was behind V2. The collision occurred when V1 changed lanes and entered V2's lane of travel. This caused V1 to impact the rear right end of V2. On scene I observed damage to the rear right end of V2 and front left end of V1.

The driver of V2 stated she was traveling westbound on Route 70 and was sideswiped by V1. The driver of V1 stated she was changing lanes when she struck V2. All parties involved declined first aid attention. Both vehicles were removed from the roadway prior to my arrival. The driver of V1 was issued a careless driving ticket (39:4-97, t-159507).

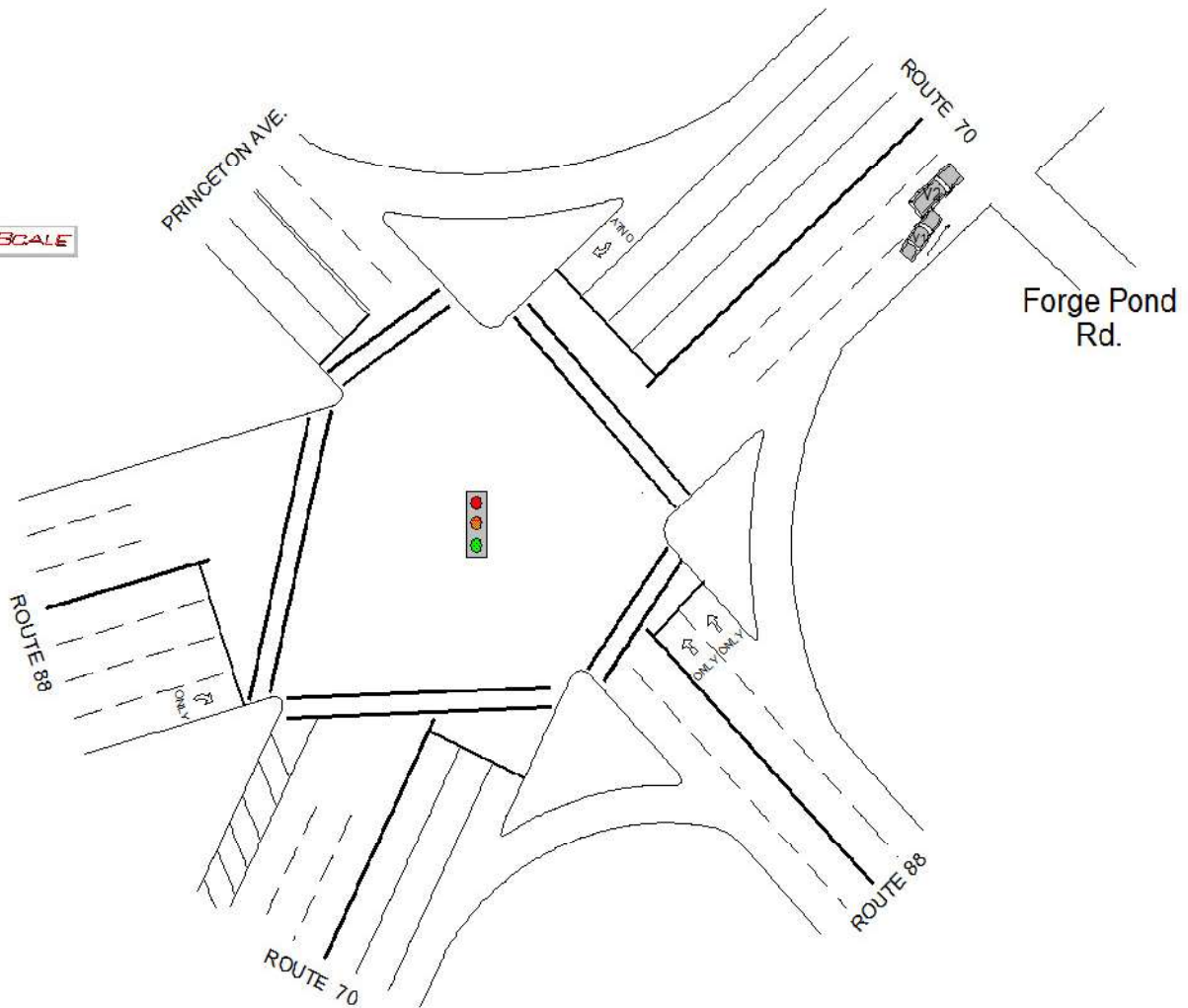
