145. Crash Description/Narrative

Vehicle 2 had stopped at the red lit intersection on Jack Martin Blvd with Rt 88. Vehicle 1 was directly behind

Vehicle 2, in line at the same traffic light.

Driver 2 stated she had moved forward in traffic to prepare to turn right onto Rt 88, and was looking for

Westbound traffic.

Driver 1 stated he believed Vehicle 2 had moved forward and proceeded onto Rt 88. Driver 1 stated he turned his

head to look for Westbound traffic and failed to observe that Vehicle 2 had only partially moved forward before

stopping again.

The front of vehicle 1 contacted the rear of Vehicle 2.

I observed no external damage to either vehicle.

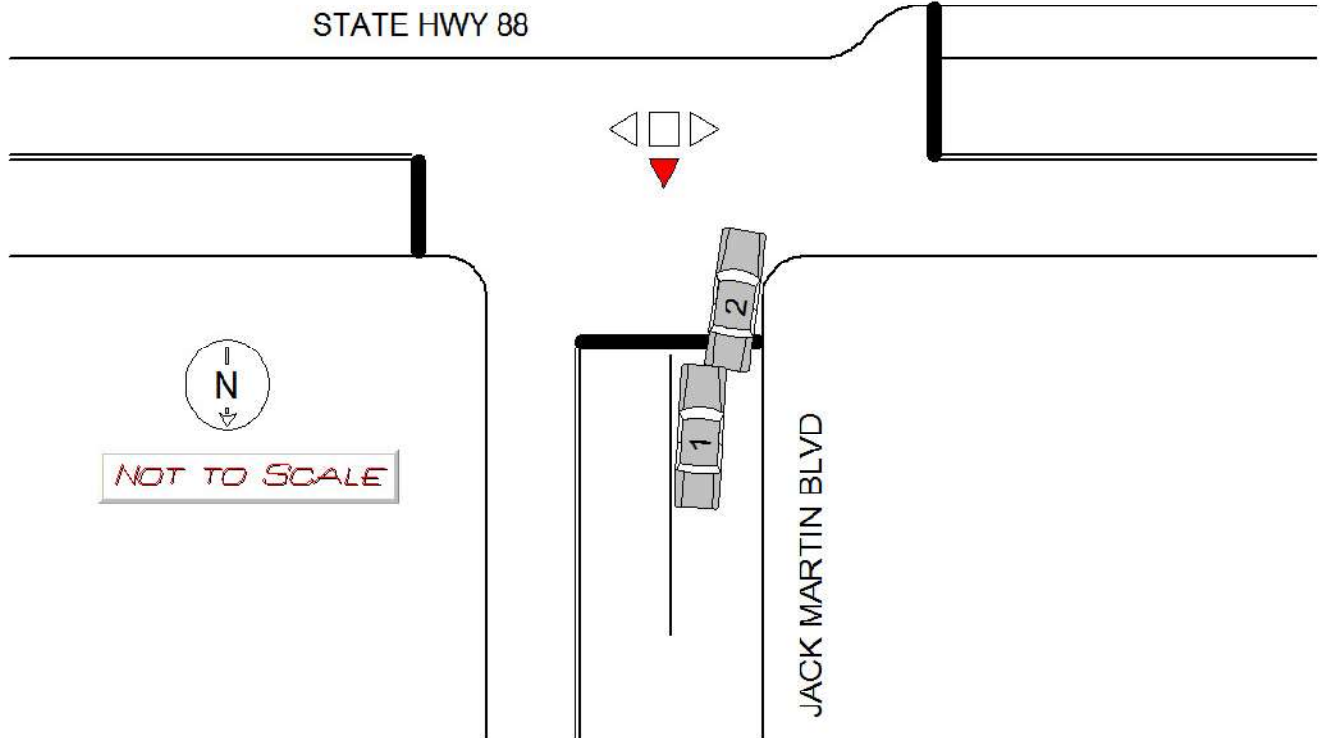
