145. Crash Description/Narrative

Vehicle 2 stopped waiting for traffic on Route 88 westbound, to attempt a left turn into the parking lot of 2125 Route 88. Vehicle 1 traveling westbound on Route 88 directly behind Vehicle 2.

Driver 1 stated he was traveling on Route 88 westbound approaching Hoover Drive when he was distracted by his 4 year old daughter. He looked to the passenger side rear for a moment, where she was seated. When he looked forward again, Vehicle 2 was stopped directly in front of him. Driver 1 stated before he could react, he struck the rear of Vehicle 2.

Driver 2 stated she was stopped on Route 88 westbound and waiting to turn left into the parking lot of 2125 Route 88. Driver 2 stated as she was waiting for traffic to clear, she was struck from behind by Vehicle 1.

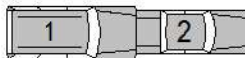
