145. Crash Description/Narrative

Vehicle 1 was traveling North on Brick Blvd. in the left most traveling lane when it struck Vehicle 2 in the rear bumper with its front bumper. Vehicle 2 was stopped in traffic in the left most traveling lane on Brick Blvd. northbound. Both vehicles received minor damage.

Driver 1 stated he looked down for only a moment and when he looked up he didn't have time to stop before causing the motor vehicle accident. Driver 2 advised she was stopped in traffic when her vehicle was struck.

Based on my observations and statements made by both drivers, I find Driver 1 at fault for failing to keep his attention on his vehicle's traveling lane. Driver 1 was issued traffic summons T-160423 for careless driving (39:4-97).

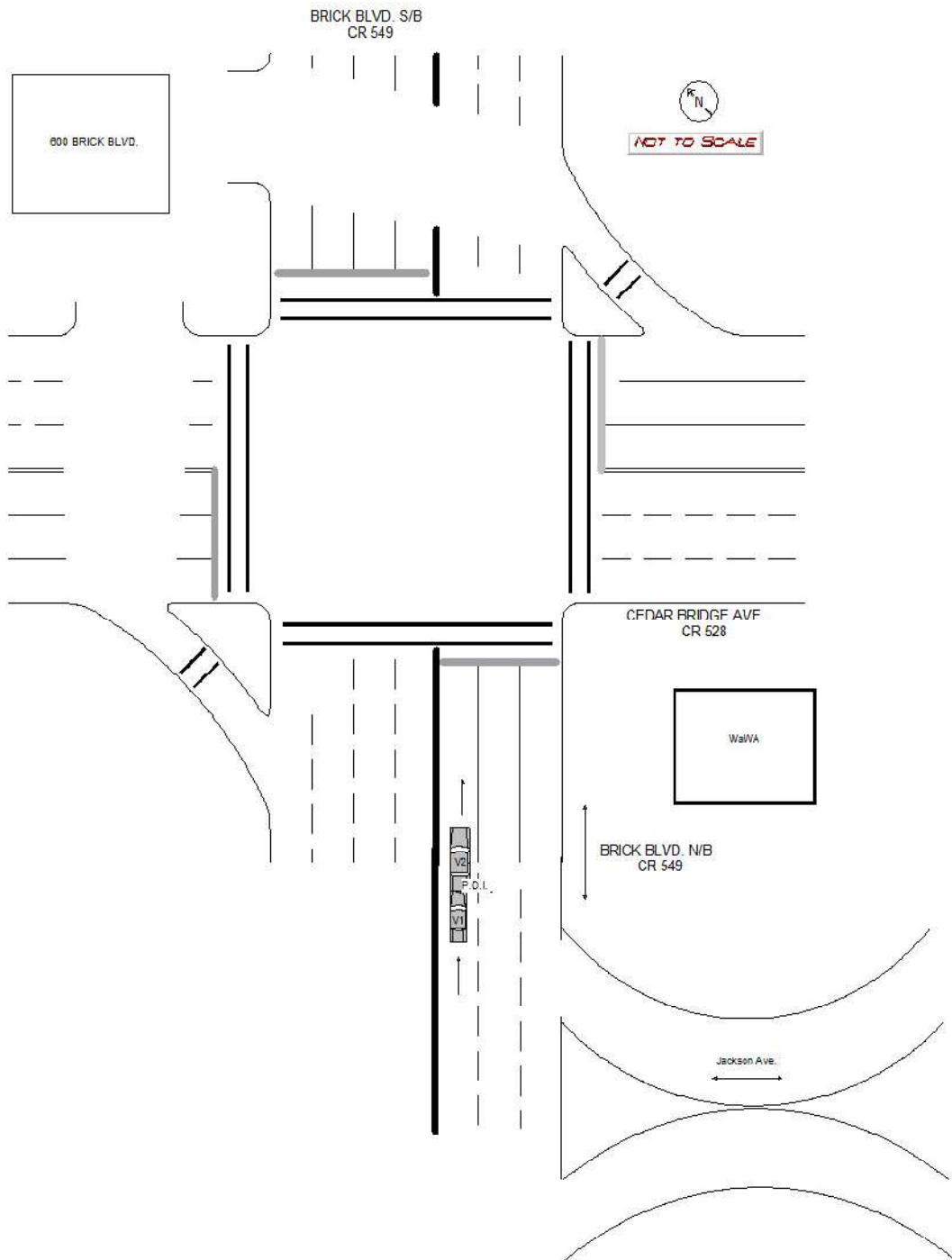
