145. Crash Description/Narrative

On arrival I observed vehicle #1 and vehicle #2 pulled over on the side of the road of Jack Martin Blvd and Route 88 west. As I approached the vehicle, I observed damage to vehicle 1 on the driver side and damage vehicle #2's driver side.

Driver #2 explained he was making a left turn from Route onto Fort Street when Vehicle #1 was negotiating a left turn onto Route 88. As his vehicle 2 was making the left turn vehicle #1 approached the intersection and side swiped his vehicle. After the collision, vehicle #1 continued on Route 88. Driver #2 was able to catch up to vehicle #1 and advised him he crashed into his vehicle.

Driver #1 explained he was making a left turn onto Route 88 from Fort Street. He explained he did believe he hit

another vehicle and continued on Route 88. Driver #1 explained that D#2 found him and he pulled over to the side of the road.

As I spoke to Driver #1, I detected a sweet smell coming from his breathe. I asked Driver #1 if he was drinking tonight. Driver #1 explained he does not drink but he is a diabetic. I requested Brick EMS to respond to the scene for a diabetic emergency. Prior to their arrival, I asked Driver #1 to conduct a field sobriety test. Driver #1 was not familiar with the English language due to the fact he was from Italy. I attempted the one legged stand with Driver #1 which he could not perform because he advised me he has bad knees. Driver #1 again explained he was not drunk and does not drink. I could not detect the smell of alcohol on Driver #1's breathe but could still smell the sweetness. Brick EMS arrived on location and asked questions and asked Driver #1 if wanted to go to the hospital for a diabetic emergency, which Driver #1 refused.

I did not believe Driver #1 was under the influence of alcohol or any type of narcotics. I was able to contact his son who arrived and picked up his father.

In my observations I find vehicle #1 at fault for the crash.

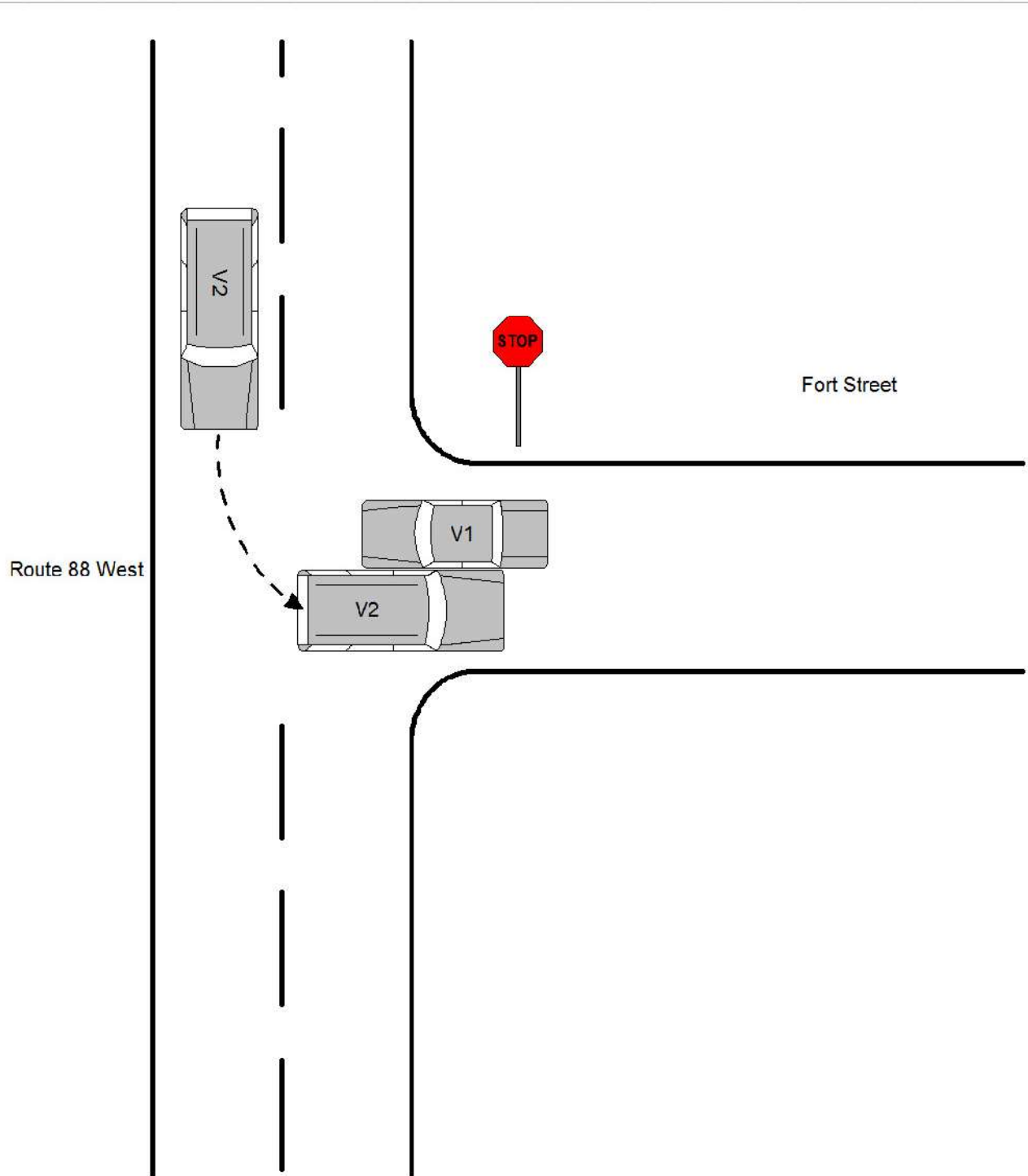
