145. Crash Description/Narrative

On scene investigation concluded: Vehicle #1 and #2 were traveling on Rt. 88 attempting to make a left turn onto Rt. 70 (Westbound). Both Vehicle #1 and #2 were stopped at the red traffic signal as the lead vehicles in the left two lanes. Vehicle #2 was in the far left lane, began to make the left turn after the green traffic signal and was about to enter the left lane of travel on Rt. 70. Vehicle #1 attempted to enter the far left lane from the middle lane of travel during the left turn and struck Vehicle #2 as it entered the far left lane of Rt. 70. Vehicle #1 is at fault.

Driver of Vehicle #1 advised she was the first vehicle in line in the far left lane on Rt. 88 attempting to turn left onto Rt. 70. Driver of Vehicle #1 relayed she began her turn and was about to enter the lane of travel on Rt. 70 when Vehicle #2 came out of nowhere and hit her vehicle.

Driver of Vehicle #2 advised he was stopped in the left lane on Rt. 88 when he observed the green traffic signal. Driver of Vehicle #2 relayed he made his left turn towards Rt. 70, was about to enter the left lane of travel on Rt. 70 when vehicle #1 struck his vehicle.

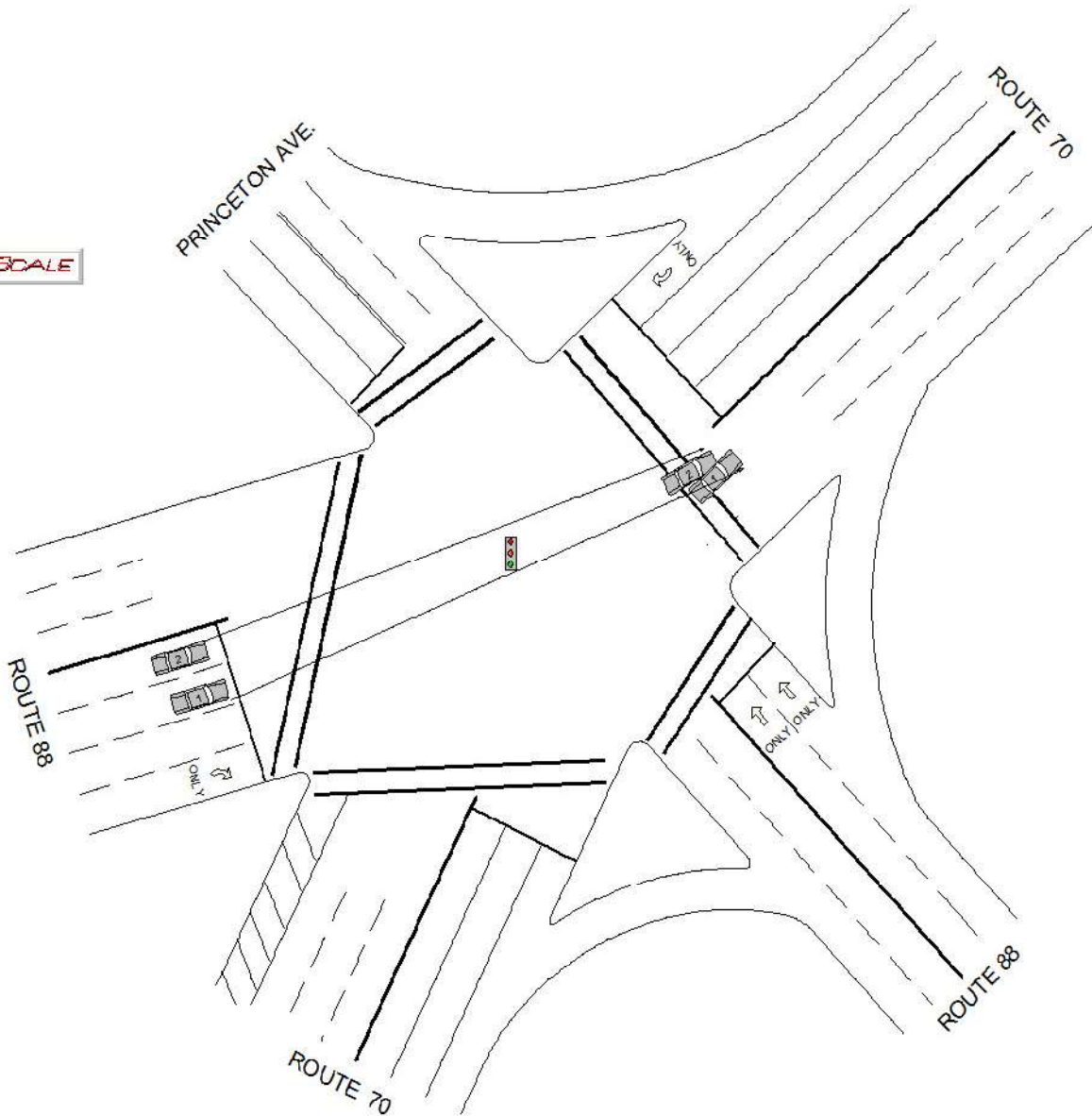
