145. Crash Description/Narrative

Driver of V2 stated he was parked in a parking spot in the parking lot of 2108 Route 88 directly adjacent to V1.

Based on my investigation and observations on scene I determined V1 to be at fault for the motor vehicle crash.

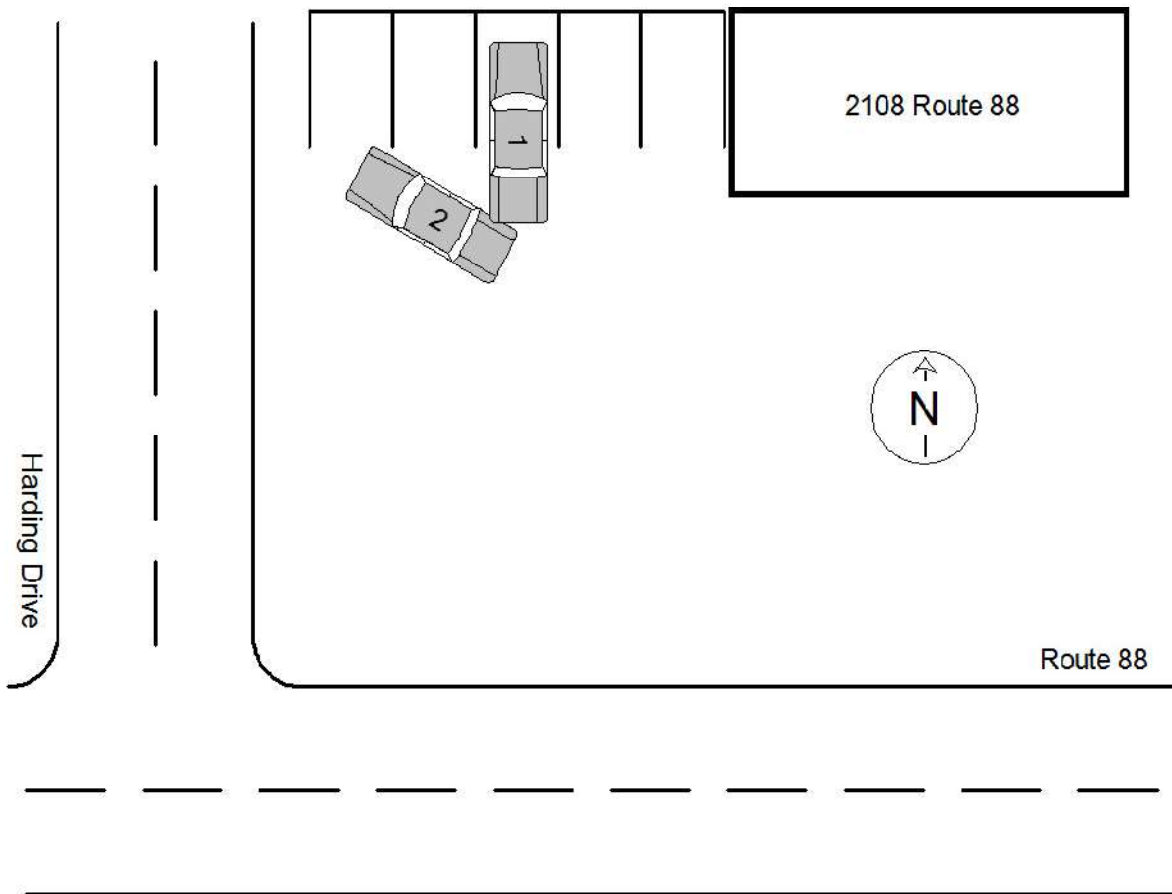
