145. Crash Description/Narrative

Vehicle 2 was traveling east on Route 88, making a left turn into the Home Depot parking lot. Vehicle 1 attempted a left turn, from a right turn only lane from the parking lot of Home Depot and struck vehicle 2.

Vehicle 1 sustained minor damage to the right front. Vehicle 2 sustained damage to the left rear. Neither driver sustained any injuries.

The driver of vehicle 1 stated, "I was making the left turn from Route 88 going into the Home Depot parking lot, when the other car struck into my vehicle".

The driver of vehicle 2 stated, "I attempted to make a left turn onto Route 88 and I struck the other vehicle. I didn't realize it was a right turn only."

Upon completion of my investigation, vehicle 1 was to be found at fault.

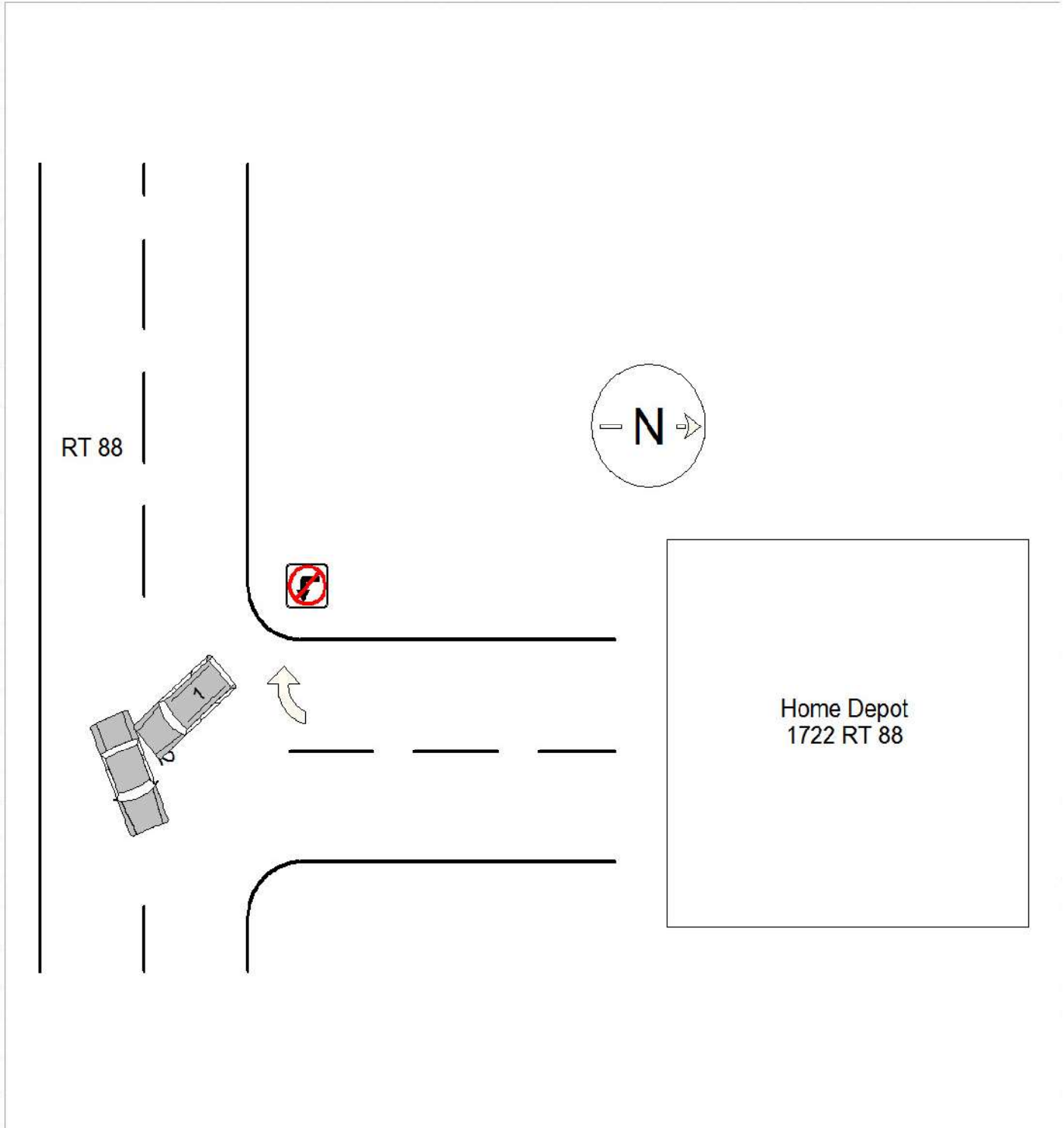
