145. Crash Description/Narrative

Vehicle 1 was traveling East on Rt 88 in the right lane , vehicle 2 was in the left lane on Rt 88 East and both were approaching Post Rd. Vehicle 1 came into the lane of travel of vehicle 2 causing the collision.

The driver of vehicle 1 complained of head pain and was transported to Jersey Shore Medical Center for further treatment. The passenger of vehicle 1 , a 2 year child was also transported for precautionary reasons.

Vehicle 1 had extensive drivers side damage and was towed.

The driver of vehicle 1 stated she was traveling on Rt 88 East in the right lane but did not exactly remember how the crash happened and was unable to give a full statement of the crash.

The driver of vehicle 2 stated he was traveling on Rt 88 East in the left lane when vehicle 1 came into his lane of travel pulled in front of him and collided with his vehicle. He stated it appeared vehicle 1 was trying to make a U-turn.

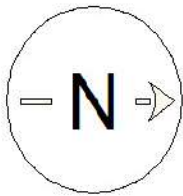

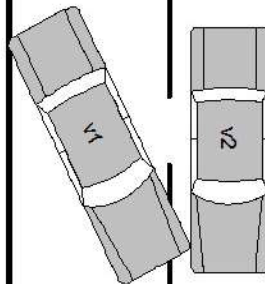
144 Crash Diagram (NOT TO SCALE)
