145. Crash Description/Narrative

Vehicle#1 was traveling West on Route 88 in the area of Brunt Bridge Ave. Vehicle#2 was stopped in traffic

to make a left turn into the parking lot of Dim Sum Chinese Restaurant located prior to Brunt Bridge Ave.

Vehicle#1 failed to come to complete stop causing Vehicle#1 to crash into Vehicle#2. Driver#1 stated that he was

distracted and did not see Vehicle#2 stopped until it was too late. Driver#2 stated that she saw Vehicle#1

approaching and when she saw he was not stopping she attempted to pull forward just prior to the crash. The

investigation determined Vehicle#1 to be at fault. Driver#1 sustained a head injury but refused first aid.

Driver#2 complained of neck pain and was transported to Ocean Medical Center.

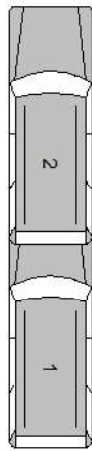
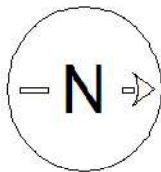
144 Crash Diagram (NOT TO SCALE)
