145. Crash Description/Narrative

Ptl. Ulman was operating vehicle #02, marked police vehicle #36 traveling eastbound in the parking lot of 2170 Route 88 (Colonial Funeral Home). Vehicle #01 had just turned into 2170 from Route 88 and was continuing (northbound) straight ahead.

I spoke with Ptl. Ulman, who stated as he was passing in front of vehicle #01, he observed the driver turn back to look at the traffic on Route 88 as she was approaching him. He stated he began pressing the center of his steering wheel to sound the horn and alert the driver of vehicle #01, so she would realize a vehicle was in front of her. She did not notice in time and collided with the front passenger door of vehicle #02.

I spoke with the driver of vehicle #01 who stated she pulled in the Colonial Funeral Home parking lot and continued straight, while looking forward the whole time. She went on to say she didn't see vehicle #02 until she collided with the side of it.

Based on the evidence of the crash and statements from both drivers, I deemed vehicle #01 to be at fault. The front passenger door of vehicle #02 was damaged and would not open. Vehicle #01 had paint transfer and minor

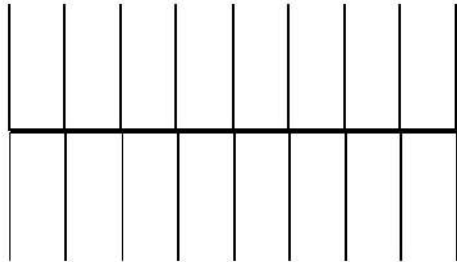

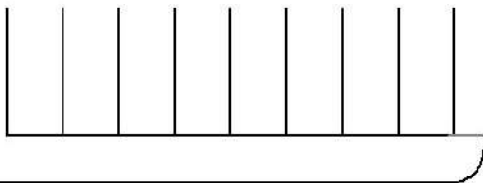
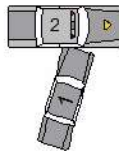
