145. Crash Description/Narrative

Driver of Vehicle 1 stated that while she was attempting to park her vehicle on the north side of Leslie Pools, 1930 Route 88, her vehicle struck the building. Driver 1 further advised that as she was pulling into the parking stall, she applied the brake pedal. She reported that the brake pedal went all the way to the floor.

Driver 1 stated that she did not apply the emergency brake and the vehicle struck the building.

Driver 1 was not injured at the time of the crash. Driver 1 was issued Summons T159739 for Careless Driving. 39:4-97.

Note: After the crash, Vehicle 1 was backed away from the wall by Driver # 1. At that time, there was no issue with the brakes as Driver # 1 applied the brake pedal.

Ken Kiseli, Brick Township Building Subcode Official, responded to the scene. The building was deemed safe to remain open. There were several cracks to the interior sheet rock, a large number of displayed for sale product containers knocked off the shelves, and small cracks to the exterior blocking.

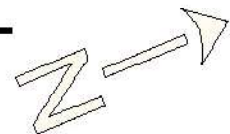
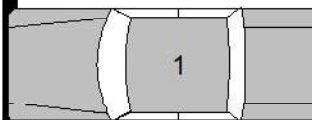
