145. Crash Description/Narrative

Crash investigation reveals a two vehicle, same direction (Rear-End) crash. Vehicle 2 was stopped for traffic on

Route 88 traveling west at the intersection of Route 88/Roosevelt Drive. As vehicle 2 was stopped for traffic on

Route 88 W, the driver of vehicle 1 was traveling directly behind vehicle 2. After vehicle 2 came to a stop, the

driver of vehicle 1 stated he didn't see vehicle 2 come to a stop on Route 88 which caused the front end of

vehicle 1 to crash into the rear of vehicle 2.

Driver of vehicle 1 simply stated his attention was diverted very briefly and he didn't have tie to slow down and

come to a stop behind vehicle 2. No injuries were reported and both vehicles were driven from the scene. The

driver of vehicle 1 is at fault for the crash.

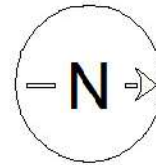
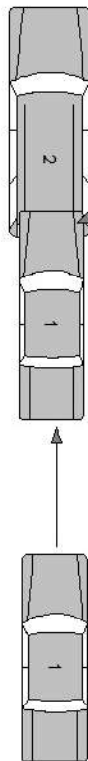
