Upon completion of my investigation vehicle 1 was to be found at fault.

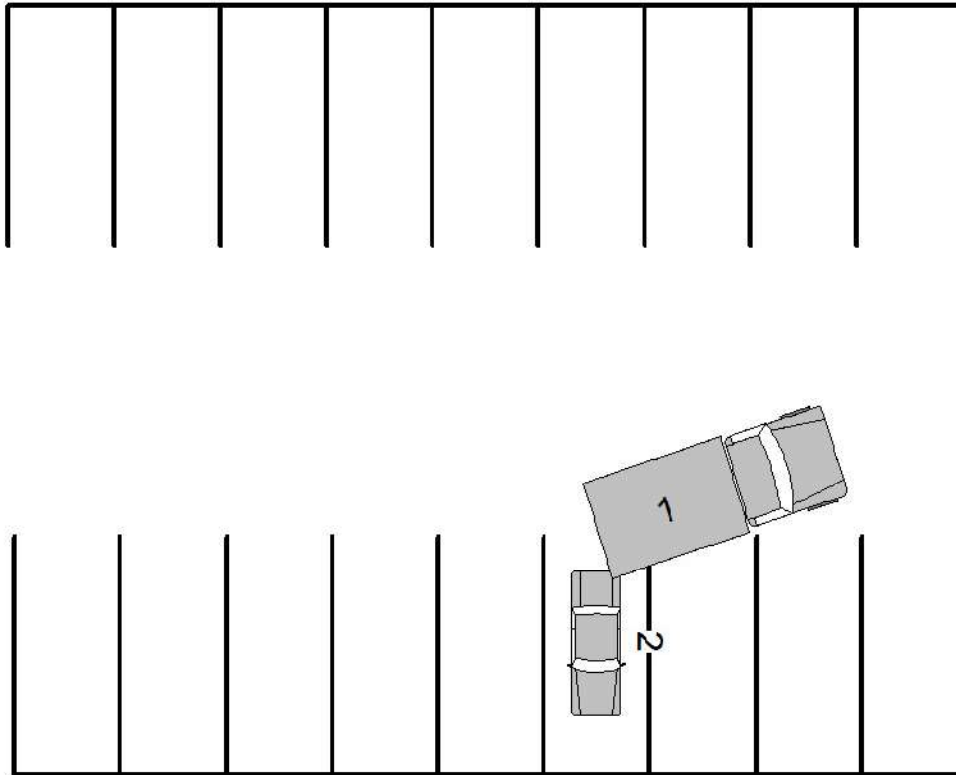
