## Narrative

On Tuesday April 1, 2025 at approximately 2340 hours I PO William Whitley #210 was parked in the parking lot of 100 Memorial Drive. It should be noted that this is a high crime area where a lot of foot traffic and narcotics are sold in this area. While I was sitting there I was addressing a female subject regarding not leaving her vehicle idling while she went inside the store. During the time of advising the female I could hear a subject later identified as Nancy E Phillips [REDACTED] yelling towards me. Also note that there were several subjects standing in front of the Spot convenient store. At this time I exited my vehicle activating my body worn camera and began walking towards the Spot convenient store. While walking towards the store Nancy was yelling and screaming about the Asbury Park Police and using profanities towards me while recording me with her cell phone. I had a brief conversation with Nancy about standing in front of the store along with the other subjects. The few subjects stood around the area along with Nancy however she alone continued yelling profanities towards me. Nancy was advised to lower her tone several times but she continued on with her ranting.

At this time I walked inside the store to show my presence for a few minutes and began speaking with the subjects in the store. I then went back outside and Nancy again continued yelling and using profanities towards me. I asked Nancy to lower her voice again but she refused. It should be noted that there were people standing outside their vehicle and standing near the store. While Nancy was yelling and using profanities towards me, she was causing a crowd to gather while becoming more disorderly. At this time I advised Nancy that she was being placed under arrest for disorderly conduct. I attempted to place my handcuffs on Nancy where she pulled her left arm away refusing to be arrested. I advised Nancy to stop resisting and she continued to pull her arm away. After a brief struggle, Nancy was finally handcuffed behind her back without further incident and placed in the rear of my marked vehicle. She was transported to headquarters for processing.

While at headquarters Nancy was checked for warrants yielding negative results. Nancy was charged with Disorderly Conduct and Resisting Arrest and was later released on summons 1303 2025 000379.

A Use of Force report was completed for this incident.
