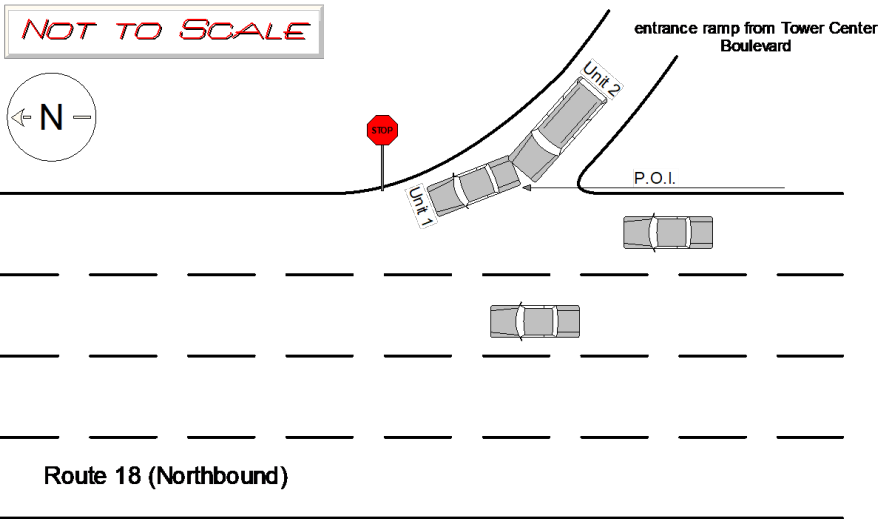

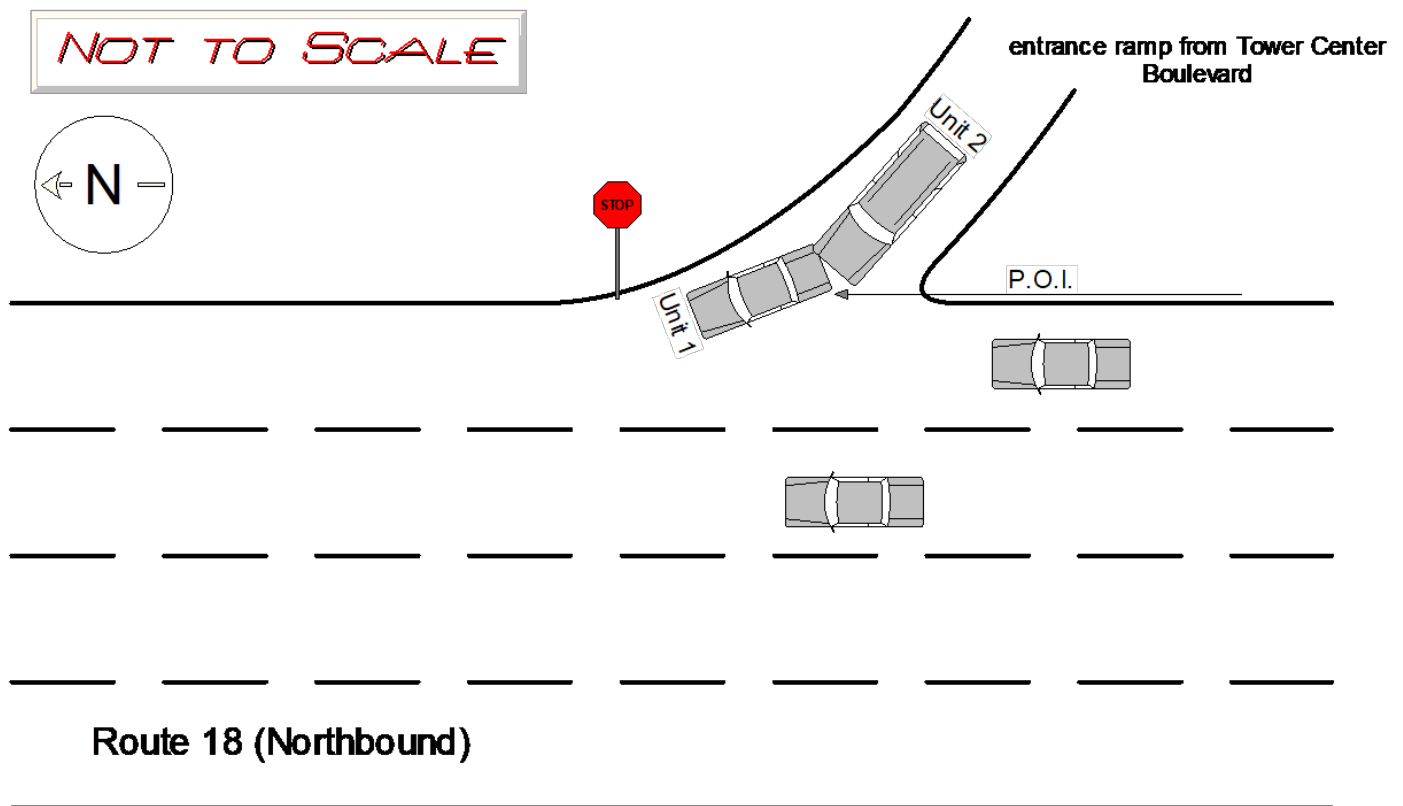
145. Crash Description/Narrative

Vehicle 1 was stopped for the posted stop sign on the ramp from Tower Center Boulevard, attempting to merge onto Route 18, when northbound traffic was clear. As the traffic was flowing steadily, Vehicle 1 remained stopped. Vehicle 2 was directly behind Vehicle 1 also attempting to merge onto Route 18 northbound. The driver of Vehicle 2 observed an opportunity to merge and began to travel forward, unaware that Vehicle 1 remained stopped directly in front. Due to this, the front bumper of Vehicle 2 crashed into the rear bumper and rear hatch door of Vehicle 1.
