Mr. Wise,

The Township of Washington received your Open Public Records Act (OPRA) requests on September 7, 2022. The official Records Custodian, Susan Witkowski, received your OPRA request on September 7, 2022. As such, the seven (7) business day deadline to respond to your request was September 16, 2022. An extension was requested via letter dated September 14, 2022 until October 3, 2022.

The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
