I AM NOT seeking records in connection with a legal proceeding.

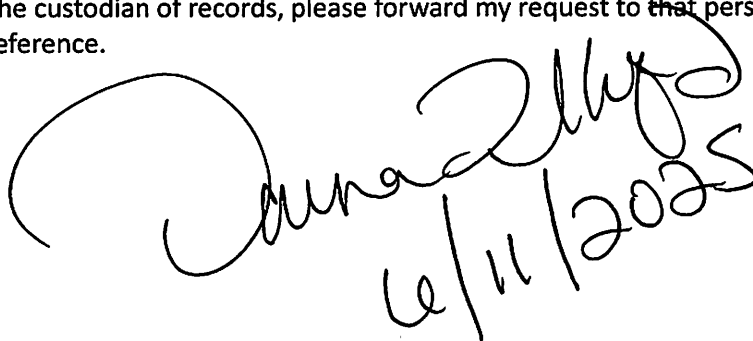
