Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On Monday, December 2, 2019, at 12:21 a.m., the Eatontown Police Department received a report of a possible overdose victim in Room 137 at the Crystal Inn Motel. The responding officers located Raul Garcia lying on the bathroom floor of Room 137. He was unconscious and not breathing. Emergency medical assistance was performed in the form of CPR and several administrations of Narcan. Despite the efforts of the Eatontown Police Department, the Eatontown First Aid Squad, and the MONOC Paramedics, pronounced Raul Garcia deceased. An investigation initiated by the Eatontown Police Department and the Monmouth County Prosecutor's Office revealed that Raul Garcia's girlfriend, Katherine Jones hours prior to his death, took Raul Garcia to the Lukoil Gas station to meet with his drug supplier to purchase heroin. Surveillance footage recovered from this location showed Raul Garcia meeting with a vehicle whose occupants were later identified as John Molloy, George Cucuzella, and Nicole Ricciardi. A review of Raul Garcia's phone showed Communications related to the possession and purchasing of heroin during this time at the Lukoil Gas Station. It also revealed another purchase of heroin involving the same telephone number that occurred earlier in the day at Raul Garcia's room at the Crystal Inn. Surveillance video of this incident showed the same vehicle along with John Molloy and George Cucuzella meeting with Raul Garcia in the parking engaging in a narcotics related transaction. A complete review of the cellular phones involved in the investigation revealed George Cucuzella and Nicole Ricciardi utilizing cell phones to facilitate the sale to Raul Garcia and even borrowed John Molloy's to complete the transaction. On December 5, 2019, following a motor vehicle stop, John Molloy spoke with Detective Camacho of the MCPO and Det. Gugliuzza. John Molloy advised that George Cucuzella asked him to give him a ride to the Crystal Inn to make a sale of heroin to Nicole Ricciardi's friend Raul Garcia. John Molly further stated that he and George Cucuzella went together on the earlier sale and that Nicole Ricciardi was present and involved in the sale prior to Raul Garcia's death. On both occasions, John Molloy indicated that Cucuzella sold a quantity of heroin to Raul Garcia for which he received a small amount of heroin and gas money. An examination Conducted by the Middlesex County Medical Examiner's Officer determined the cause of Raul Garcia's death as
