Dear Stace Antine

I am pleased to inform you that New Jersey Economic Development Authority ("NJEDA" or "Authority") has approved your application to participate in the Sustain and Serve NJ program (the "Program") This program will provide your organization with reimbursement for meal purchases from approved restaurants up to **\$2,000,000.00 through January 31, 2022.** This approval is based on your application dated 7/11/2021.

The approval process requires that you execute a Sustain and Serve NJ Grant Agreement ("Agreement") with the Authority. A member of the NJEDA Closing team will send the Agreement under separate cover. The Agreement establishes mutual expectations and requirements for participating in the Program as a Sustain and Serve NJ grantee. Upon signature of the agreement by your organization and NJEDA, it will allow you to apply for reimbursement from the Authority for meals purchased from eligible restaurants named in your application, listed below.

Please note that, in accordance with the Agreement, grant funds will be disbursed incrementally based on the reimbursement schedule outlined below after submission of invoices documenting meal purchases up to \$2,000,000.00. You will need to submit dated receipts or invoices for reimbursement of at least \$20,000. If expenses incurred are less than \$20,000, you must wait until the next reimbursement period once their expenses are at least \$20,000. You may choose to submit less than once a month, but all expenses must be submitted for reimbursement by February 4, 2022. **Expenses submitted after February 4, 2022 will not be reimbursed.**
