Please be advised that your request is denied because personnel records are exempt from public access pursuant to N.J.S.A. 47:1A-10, with the exception of "an individual's name, title, position, salary, payroll record, length of service, date of separation and the reason therefor, and the amount and type of any pension received shall be a government record."

Notwithstanding the above, you are being provided with a spreadsheet of current LPS employees as January 18, 2026. The spreadsheet includes the first name, last name, date of hire, current position description and Division employer.

Your request is hereby closed.

Regarding #2: For example, if an employee was demoted from the rank of lieutenant to the rank of sergeant, I am requesting the employee's first name, last name, badge/identification number and date they were demoted from lieutenant to sergeant.
