Dear Mr. Paff:

As custodian of records for the Absecon Board of Education ("Board"), I am writing this letter in response to your request for records pursuant to the Open Public Records Act (OPRA) submitted via email on Sunday, January 31, 2021 and received on Monday, February 1, 2021.

The Board's response to each of your specific requests is set forth below.

1. **For Dr. Daniel J. Dooley, his "name, title, position, salary, payroll record, length of service, date of separation and the reason therefor." (See N.J.S.A. 47:1A-10)**

See enclosed report providing Dr. Dooley's name, title, position, salary, and date of appointment. As Dr. Dooley is currently employed with the Board, there is no date of separation. Also enclosed is a copy of Dr. Dooley's payroll record, for July 1, 2018 through the present.

2. **Dr. Daniel J. Dooley's resume.**

Personnel records are not government records and are therefore prohibited from disclosure pursuant to OPRA. See N.J.S.A. 47:1A-10. Redactions of personal email addresses, personal cellular telephone numbers and home addresses are permissible means by which an individual's reasonable privacy expectations may be protected. See Scheeler v. New Jersey Department of Education, 2017 WL 218259 (App. Div 2017); Doe v. Poritz, 142 N.J. 82 (1995) (regarding the privacy concerns associated with the release of home address information); Flora v. Ocean County Health Department, GRC Complaint No. 2013-188 (2015) (regarding the redaction of personal cellular telephone numbers to protect an individual's privacy interest); D' Andrea v. N.J. Civil Service Commission, GRC Complaint

No. 2014-153 (2015) (regarding the propriety of redactions of personal email addresses). Accordingly, enclosed please find Dr. Dooley's resume, which has been redacted to protect confidential personal information pursuant to N.J.S.A. 47:1A-10.

Since the records identified above are being provided to you in electronic format only, there is no charge associated with your request. The foregoing information and attached documents constitute a full and complete response to your OPRA request by the Absecon Board of Education and therefore, your OPRA request is closed.
